downloaded for reference during the term of office. For the quartermaster, there are several training documents and each year there is a Quartermaster Guide with the current years information for use during the year. There are forms and examples to look at and use. There are videos in the national web site for the QM to review.

For the trustees, there is a publication to use as a guide for the proper review of the entity's finances. There are forms to use for accurate review of the QM and Adjutants books and records.

Quatermaster, continued

Every entity which has a not-for-profit status, MUST file a 990 annually. If your Post, County Council or District is on a calendar year, begin to file today. If your Post, County Council or District is on the VFW fiscal year, July 1 thru June 30th you need to begin to gather the documentation for filing. Just a couple of notes on 990's, First, the 990 is not a tax return, rather a report of financial activities. Second, every 990 is open to inspection by anyone who wishes view it. This means anyone, Post members, Auxiliary members and/or anyone from the public. Refusing to show anyone a 990, it is a Federal violation, not a Department of New York or VFW violation. If you go online to start filing a 990 and you cannot locate your information, it might be because someone in your organization did not file for 3 years. THERE IS NO WARNING TO ALERT YOU THERE WAS NOT A 990 FILED FOR 3 YEARS, IT IS AUTOMATIC.

Reestablishing the organization's not for profit status is expensive, time consuming and mountains of paperwork.

Inspections are designed to ensure that Posts are operating in a manner that is consistent with our National Bylaws and Manual of Procedure. Our District inspection teams are there to assist you if you are having any difficulties. As a reminder, consideration for a Post All-State Award requires that your Post be inspected prior to April 30, 2022 and that your Inspection Report is received and approved by the Department prior to May 3, 2022.

Comrades,

The <u>Department of Veterans Affairs</u> will change its disability ratings criteria for mental health conditions, sleep apnea and tinnitus, part of a major overhaul of the review process to ensure that compensation matches veterans' medical conditions and needs, department officials say. The VA plans to update its Schedule for Rating Disabilities -- its guide for determining how it evaluates and provides benefits for serviceconnected disabilities -- for mental health conditions, to include their impact on veterans' lives, and abolish the "0%" disability rating for any service-connected mental health diagnosis in favor of a 10% minimum, according to a notice published Tuesday in the Federal Register.

For tinnitus, the department will get rid of its stand-alone rating and consider the condition a symptom of whatever underlying disease is its cause.

As for sleep apnea, ratings will be assessed based on the effectiveness of treatment and the condition's impact on "earning impairment," according to the notice. Previously, most conditions were assessed on the number and severity of symptoms, but VA officials said the consideration of lost wages or productivity is needed to ensure that the department compensates veterans appropriately. Officials say the changes, which would go into effect after a period for the public to comment and a final version is published, likely will result in higher disability ratings for veterans with mental health conditions, but fewer qualifying for disability compensation for tinnitus and sleep apnea.

Veterans already receiving disability for these conditions will not see their ratings downgraded by any changes, officials said.

"Veterans who currently receive compensation for a service-connected condition in these body systems will not have their disability rating impacted when the VA Schedule for Rating Disabilities is updated," Thomas Murphy, acting VA undersecretary for benefits, said in a press release.

Assessing disabilities by the impact they have on

earning capacity will allow the department to "more accurately compensate [veterans] for their service-connected disabilities, officials said in the Tuesday press release.

"Updating the rating schedule allows veterans to receive decisions based on the most current medical knowledge relating to their condition," Murphy said.

Under the proposal for mental health conditions, the VA will consider a condition's impact on cognition, relationships and ability to complete tasks, care for oneself and perform activities necessary for functioning daily.

Citing studies that showed the current VA disability rating system does not adequately provide compensation to make up for earnings lost if a veteran misses work or can't work as the result of a service-related mental health condition, the department plans to adopt the new criteria to "more accurately capture the occupational impairment caused by mental disabilities and provide more adequate compensation," according to the notice.

The new criteria also will be used to assess disability ratings for eating disorders, which currently are outlined in a separate part of the disability ratings schedule.

Officials said an overhaul of the system is underway because the disability ratings evaluation schedule has been updated piecemeal since it was first created in 1945.

To date, the VA has completed updating 10 of the 14 sections of the schedule; the proposed changes to mental health and the section that covers tinnitus and sleep apnea make up half of the remaining.

VA officials said the changes made to the criteria reflect modern medicine and a better understanding of how diagnoses and treatments affect veterans' lives.

Speaking with reporters during a press conference Monday, a VA benefits official noted that when overhauling the section on musculoskeletal injuries, the department shortened the time period for veterans to receive disability payments following a hip replacement from 12 months to four.

"We looked at more recent medical studies ... and found that the time somebody is off of work after having that surgery is closer to three months ... so we made a revision to that portion," the official said.



The VA is seeking public comment on the proposed changes to the ratings schedule

through the Federal Register. After the comment period closes April 18, the department will review them and draft a final version, to include the dates the changes will go into effect.

Once the changes are made, veterans who believe their ratings should be upgraded based on the new criteria should file a claim, the official said. "We anticipate seeing higher evaluations for mental health conditions," the official said.

Comrades,

The Department of Veterans Affairs will propose adding certain rare respiratory cancers to the list of presumed service-connected disabilities in relation to military environmental exposure to particulate matter.

When the proposal becomes final, dependents, survivors, and Veterans who had claims previously denied for any of the below respiratory cancers would be encouraged to file a <u>supplemental</u> claim for benefits.

- Squamous cell carcinoma (SCC) of the larynx;
- SCC of the trachea;
- Adenocarcinoma of the trachea;
- Salivary gland-type tumors of the trachea;
- Adenosquamous carcinoma of the lung;
- Large cell carcinoma of the lung;
- Salivary gland-type tumors of the lung;
- Sarcomatoid carcinoma of the lung and;

Typical and atypical carcinoid of the lung.

Any Veteran who had one of these cancers manifest to a degree of 0% or more at any time during or after separation would become eligible for service-connection.

VA intends to focus its rule on the rare respiratory cancers above in Veterans who served any amount of time in the Southwest Asia theater of operations and other locations. VA will invite and consider public comments as part of this process. The publication date of the federal register will occur in the coming weeks.

Once rulemaking is complete, VA will conduct outreach to impacted veterans and survivors to inform them about potential eligibility.

The Southwest Asia theater of operations refers to Iraq, Kuwait, Saudi Arabia, the neutral zone between Iraq and Saudi Arabia, Bahrain, Qatar, the United Arab Emirates, Oman, the Gulf of Aden, the Gulf of Oman, the Persian Gulf, the Arabian Sea, the Red Sea, and the airspace above these locations.

If you are a Veteran who has been diagnosed with one of these conditions, but have not filed a claim, please notify VA of your intent to file a <u>claim</u>.

For every new to the VFW Life Member and/or an Reinstated Annual to Life with full Life Member payment the Post will receive \$30.00

For new/or Reinstated Annual to Life with Life Installment plan the Post will receive \$20.00

New to VFW Annual member the Post will receive \$20.00

Reinstated Annual member the Post will receive \$10.00

The 2nd incentive is the Department Commander's Special Drawing for a Henry VFW Tribute Rifle which will be given away at the State Convention in June. For every new or reinstated member a comrade recruits, he or she will receive one ticket in the drawing for the Henry Tribute Rifle. For example, if a comrade recruits 15 new or reinstated members, that individual would receive three entries in the drawing, etc.

The dedication of the Staten Island Ferry SSG Michael Ollis

On February 14, 2022 the newest Staten Island ferry was dedicated in honor of SSG. Michael Ollis who was born in New Dorm, Staten Island. Along with his parents—Robert and Linda Ollis members of VFW 9587 the SSG. Michael Ollis Post, American Legion Posts 126 and 1320 of Staten Island, dignitaries and officials of New York City, New York State Government and Congress and veterans gathered for a pre-launch press conference, launch and maiden voyage.

Michael was deployed to Afghanistan with the 2nd Battalion, 22nd Infantry Regiment, 1st Brigade Combat Team, 10th Mountain Division (Light). Unfortunately, Michael was Killed in Action on 28 August 2013 by giving up his own life by protecting a Polish soldier and his fellow soldiers during an attack by a suicide bomber at their Forward Operating Base (FOB Ghazni).



MAP: Adopt a Unit- 7 grants



Comrades,

Since my last report to you I attended the Washington Legislative Conference where a workshop and formal C of A was held and National Commander Mihalcic gave his testimony to the Senate and House Committee on Veteran's affairs which was very well received.

During the C of A workshop Quartermaster General Debra Anderson provided a wealth of information on the financial condition of the National organization and reported on a number important committees and follow-on actions that would take place at the formal C of A during the conference.

Quartermaster General Anderson discussed VFW staffing indicating that the National organization had experienced very high turnover during the past two years . There are currently 15 vacant positions and it has become necessary to pay new employees above the minimum salary in order to compete with other employers looking for good talent. Final recommendations regarding salaries will be made as the budget is put together for 2022-23.

In order to eliminate future interest rate risk on the Employee Pension Plan the Retirement Plan Board is looking at a strategy called Liability Driven Investing or LDI, in which the assets of the pension plan are invested in fixed income securities to match the potential liabilities of the plan. LDI will be phased in over the next year or two if not sooner. To get an aggressive start National desired to contribute \$2 million to the pension plan for the current year in the hopes of reducing risk and volatility in the assets. A motion was made and passed the next day at the C of A to contribute \$2 million to the Retirement Fund as the VFW National Headquarters Plan contribution for the current year 2021-22.

Jim Lierz who serves as the employee representative, one of five appointed by the C of A to the Retirement Board term expired on February 28, 2022. An election was held by the employees and Jim was selected to serve another 5 year term. The C of A reappointed Jim for another 5 Year term.

provided an extensive explanation by item and account of how the budget is progressing for the current year. Current Unrestricted cash & investments are \$83.8 million and represents an increase of about \$5.1 million since August 2021. Sport Clips raised over \$1.5 million to support the Help-A-Hero Scholarship Program which is the largest single year amount raised for the program.

Two special items which should be of interest to you as Post Commanders and Quartermasters is the Life Member Payout for next year and the Membership Grant Program that is currently in effect.

A motion was made and approved at the C of A to authorize the following Life Membership Payouts for 2022-23 fiscal year:

Plans A, B & C \$10.50 for each Life Member (\$3.50 each to Post, Dept & National)

Plan D \$16.50 for each Life IMember (\$5.50 to each Post, Dept & National)

Plan E \$27.00 for each Life Member (9.00 to each Post, Dept & National)

In January 2022 VFW National provided Posts a grant for new and re-instated members. Although not budgeted at the beginning of the year, to keep it in place through the end of the year it could add around \$800,000 in expenses in the Membership budget. It is felt that National has the ability to absorb this cost within the current year's budget and it looks like the program is working in bringing in additional members into the VFW and will probably be extended in the future.

Lastly, which some of you already are aware, Quartermaster General Debra Anderson has retired and Assistant Quartermaster General Marc Garduno now fills that position at Headquarters.

I am due to go back to Kansas City in August for another budget and update workshop and will report to you when I return.

A lot has happened since the last article on the National Home (NH). First off There is a new Executive Director. After a nationwide search The Executive Board presented to the full Board 20 applicants that were eventually whittled down to three. Those three were called back for second and third interviews before we finally elected our new Executive Director, Michael Wilson. Mike will lead the NH for many years to come and into the second 100 years of The National Home existence.

By now you may have noticed that I have not referred to The National Home for Children as we had known it previously. That is because we have been working on rebranding The National Home, just as the VFW National had done a few years ago. Therefore, going forward, we now will be known as The VFW National Home by dropping "for Children." We still are here for the children, but we are now focusing on assisting military, veterans and their families with children as a whole. You will see this in our new "Mission Statement."

Our new Mission Statement is, "The VFW National Home assists military, veterans, and their families with children, by creating a foundation of services and resources to achieve their personal and family goals in order to move forward in a positive, safe and healthy environment."

I have been appointed chairman of Facilities and Grounds and am working with the onsite Facilities and Grounds Director, Todd Marriott. I have been gathering information on building a solar farm on the NH campus. This would be large enough to meet all of our power needs for the entire campus. This project would result in a savings of 1.260 Million dollars over the course of 30 years. I am also exploring a switch to metal roofing vs asphalt shingles.

Of the two New York Houses only the New York #1 house is currently occupied. The New York #2 House has been completely redone and awaiting a larger family to move in. This is the largest house on the NH Campus at 7 bedrooms, 4 baths and is 4,700 square feet.

Below is a story of two Post's in my District that embodies and amplify the true meaning of Commander Hoag's slogan THE TIME IS NOW and the V.F.W.'s STILL SERVING as well as LEAVE NO ONE BEHIND. Great job Post 1666 and Post 9215 and those Post's that contributed.

There was no reason to change their words as their story speaks for itself. I just take pride in fact that I have been fortune enough to be associated with such good people.

Commander Goldsmith,

I hope this finds you well. I am writing to you to let you know about a great program that is happening in District 2.

Back in September, you sent out an email advising us of the clothing drive that Post 1666 Post Cmdr. Jim McGovern was quarterbacking for Afghanistan refugees. I have to say that this effort has been a great success.

Commander Damien Shea of Post 9215 in Upper Nyack has really taken the ball and run with it in our local community of Rockland County. He has coordinated with local Churches, schools, Mosques and individuals (via social media) with overwhelming success. I have attached several images of Damien and other members of our Post with some of the donors. Additionally, you can see the size of Damien's truck and trailer.

To date, Damien has transported 5 dump trailers totaling over 25,000 lbs. of clothing, diapers, baby items, shoes, and blankets to Ft Dix, where there are approximately 14,000 refugees right now. Commander Shea has used his own truck and trailer to transport these items. And he isn't finished. He is transporting another trailer on Wednesday 11/25/2021. As long as the donations keep coming, he will continue to make trips there. To date, we have received

donations from Islamic Center of Rockland, Good Shepheard Lutheran Church in Pearl River, St Francis of Assisi of West Nyack, St Gregory Barbarigo of Garnerville, and the Rockland Police Athletic League. Post 1666 also facilitated a transport with Tree Army in the beginning. Senator Elijah Reichlin-Melnick also donated some bags of clothing and helped get the word out for us. The West Nyack Volunteer Fire Department allowed Damien to store his trailer there when the weather was questionable. Clarkstown Police Department assisted by putting us in touch with the Imam at the Islamic Center. WRCR a local radio station in Garnerville and News12 both ran stories about this effort.

This initiative for Damien comes on the heels of a combined effort between him and our Adjutant, Mike Tritt when they assisted in getting a gentleman named Gholam and his family out of Afghanistan. Gholam was comrade Tritt's interpreter in Afghanistan and was in danger of being killed when the US left the region because of his alliance with US troops. Below is an excerpt from Comrade Tritt's write-up of the events leading up to Gholam's evacuation. Please see in italics below.

My name is SSgt Michael Tritt USAF (2002-2008) and I am a member of VFW Post 9215. I have been working tirelessly for the past 2 months trying to get my interpreter, Gholam, and his family out of Afghanistan.

Early August 2021, his town was surrounded by the Taliban. After much convincing, he agreed to let us send him \$800 which is enough money for 4 plane tickets and 1st month's rent for a place in Kabul. Unfortunately, by the time he got tickets, his town had been overrun, the airport was closed, and he was 400 miles away from the nearest possible rescue. My last message to him was he either needs to get to Kabul, or he needs to burn all of his documents and grow his beard out to blend in. His last message to me was he was going to try to make it to another province. 36 hours later he messaged me that he was in Kabul. He arrived the same weekend US troops arrived, and it was chaos at Kabul Airport.

We tried eight to ten attempts at various gates in the airport. On his first attempt, I even talked to the ANA guard who spoke perfect English to let him in, but that was the closest he ever got. Through some contacts, we had a Marine inside the airport who was going to come to the East Gate and read his name but shortly after I sent him there, I got a flash message that shots were fired and to recall Gholam. Gholam and his family watched in horror as the Taliban showed up and executed a woman and five children in front of the East Gate.

COMMANDER DISTRICT 2 continued from page 13 They fled and hid in a stranger's house who fed them and let them stay the night. On our last attempt at the gates, we sent him to Abbey Gate. It was very crowded but intel said it was the best gate for getting through that day. That is the day the bomb exploded outside Abbey Gate killing

hundreds of people and our US Marines, Soldiers, and Sailors. I thought I got Gholam and his family killed for the second time.

When he finally messaged me, he said the Taliban showed up and beat his wife with cables and shooed them away. This actually saved their lives. All this time I was calling and emailing every Congressman and Senator, and having friends and family do the same. I reached out to Lt. Generals I knew, operators I knew, and my VFW commander, who played a huge role in helping me find people on the ground in Kabul to help.

Eventually, I reached a guy who goes by the name "Duke" with Operation North Star who happened to know all the right people at a high enough level and he coordinated with his team on the ground to exfil Gholam and his family. Gholam had to pawn his wife's wedding ring to pay for one more night at the place they were staying. Operation North Star made multiple attempts at getting Gholam and his family out of Kabul. The bombing at Abbey Gate had killed five of their operators (Americans) that were running their bus evac routes. They had two ground teams to try to get Gholam out but due to Taliban presence they couldn't get to him. They reached out to the British SAS actively working exfil operations and they were happy to exfil him and his family but due to the sheer number of personnel they were trying to exfil it got called off twice. They finally opted for a covert extraction utilizing an Afghan Commando who volunteered to pick him up and drove him all the way to Mazar-I-Sharif an eight-to-ten-hour drive. This commando got him through thirteen Taliban check points and it was originally supposed to look like a Taliban kidnapping. This man swore to protect Gholam's family with his life until the rest of his team and people that they were trying to get out could catch

After weeks of moving Gholam around different safe houses, and multiple problems with keeping him on the manifest for the planes by other volunteer groups bumping him off, Duke was determined to keep him on the manifest and get him out. Gholam even stayed one night in a hotel full of Taliban sleeping on the roof and in the lobby, (third time I thought I killed him), Gholam finally made it onto the plane and landed safely in Qatar. He was able to get new clothes and toys for his kids. They had been wearing the same clothes for 2 months. It took him a few days to realize he was safe and then he broke down and cried to me. I cried with him. He is my brother. I could not

leave him behind. I am still working behind the scenes to help others who are actively being hunted by the Taliban.

These are all Americans in my eyes, they served our country with distinction, they have bled for us,_lost everything for us and have been abandoned by us. All that is keeping them afloat are veterans, active duty, and volunteers that have been working tirelessly day and night. These people are working their day jobs, making calls, and messaging their Afghan friends at night, trying to keep them calm and tell them they are not forgotten. We do this so that others may live. It is my creed from my unit. Please help donate in any way you can and show the world that America does not abandon its friends, allies, and its families.

For a follow up Gholam was told in Qatar that he could not stay but was not cleared yet, but his family was. So, he had to decide whether to take his family with him wherever they were sending him, of which they told him it would not be as nice as Qatar, or send them ahead to the United States. He chose to do what was best for his family and sent them ahead to the U.S. Meanwhile he ended up going to Kosovo where his next fight to clear his name came. He spent a month in Kosovo answering questions about what he did for the US, who he was, and if he was a terrorist. Gholam was finally released after being cleared and ended up in Ft. Dix NJ to be reunited with his family.

There he finally got to meet Damien our VFW Post 9215 Commander who was instrumental in helping Gholam get out since day 1 and continues to help out by reaching out to our local Rockland Community to donate to those in need and delivering these donations personally in his own vehicle, that is sponsored by Operation North Star. Through the combined efforts of Duke and Damien, Gholam would never be here today, receiving the clothing donations from my local community, and I would be writing a different story with a different ending. Gholam's is one of thousands out there, successful ones, and unfortunately there are ten times that of unsuccessful ones that veterans like me, Damien, Duke, still continue to fight for every day. But we must also enjoy every victory we can as we have changed the lives of those we have saved and that must be celebrated as we come upon the holidays. I have a lot to be thankful for, and right now it's having served with great people like Damien and Duke, and to continue serving with them when the call came.



BULLET POINTS FROM NATIONAL ON VA HOSPTIAL CLOSINGS

- The Asset and Infrastructure Review (AIR) Porcess rolled out its first recommendations last week. This is just the initial set of recommendations. Nothing is final yet.
- This is the beginning of a multi-year process that will include: Detailed market assessments for every VA market; Public Hearings at numerous locations around the country; and I Presidential approval plan, that has to be agreed upon by Congress.
- The goal of the AIR process is to help VA build a healthcare network with the right facilities, in the right places, to provide the right care for all veterans.
- VA's aging infrastructure needs to be addressed in order to provide world-class for the men and women who served this great nation.
- While some areas may see facilities close, others will see new VA facilities open up. This is designed to make sure the care is centered around where veterans live.
- Overall, the initial AIR report recommends expanding more than 80 new VA facilities across the US.
- New York will see some facilities be proposed to close such as the Manhattan and Brooklyn VA. But in Albany there is a proposed new VA Medical Center. In Buffalo there is a proposed new VA Medical Center. On Long Island there is a proposed super CBOC to help take some of the workload from the existing Northport VA Medical Center.
- Some CBOCs are proposed to close, but only to be replaced with Multi Specialty CBOCs
- The VFW is determined to review and monitor the initial recommendations extremely carefully. We will be providing our official feedback where necessary. And we will make sure VA continues to fulfill its promise to our nation by caring for those who served our country.



District 9 Commander Pearson, Department Commander Hoag, Department Adjutant Mitchell, and the VFW National Organization collaborated to draft a letter regarding the legislative change to the VFW National Manual of Procedure and By-Laws of eligibility requirements (citizenship) to become a member of the VFW.

This letter is being distributed in Canada, where it is estimated thousands of Canadians who have served in the armed forces of the US reside. These individuals earned the right of

membership often decades ago in the jungles of Vietnam, and battlefields around the globe in service of the stars and stripes, the flag of our country.

One such individual, Richard J. Vinet a Canadian volunteered and joined the US Army and served as part of the medical corps during 1966-1967 in Vietnam. With the stresses of the recent pandemic Alliance 180 is also assisting First Responders with this remarkable program.

For more than a decade Bob Nevins, Melody Squier and Janelle Huggard have been working together to successfully reveal the power of a horse-to-human interaction by providing transformative equine experiences for veterans living with the effects of trauma.

At a recent District 3 meeting Bob provided the members with a video of how Alliance 180 helped one special veteran overcome his effect of trauma by providing a transformational equine experience. When veterans experience trauma, the autonomic nervous system responds in a way that can be described as a "short circuit" often causing the person to shut down and become detached and closed off laying the groundwork for possible

veteran suicide.

Alliance 180 is a three day program which provides peer-to-peer interaction, private accommodations and classroom training to learn the language of the horse and an eventual round-pen interaction as the final culminating event.

Bob's program has shown remarkable results with over 800 veterans having gone through the program. Alliance 180 provides the three day experience at no cost to the veteran.

Alliance 180 is committed to preventing suicide and reducing the effect of trauma for fellow Veterans and First Responders. There is confidentiality and consistency throughout the experience maintaining the highest level of integrity that always places its mission above all else.
