Failure to provide a completed inspection report will result in no credit being given for the Membership Award Program.

I will do my best to support all of you this year.

Congratulations to PSC Jack Veazy and the officers who served with him on an outstanding year.

Next year's State Convention will be June 13-17, 2012. The State Convention is earlier due to a change in the National Bylaws, which resulted in the National Convention being held July 21-25, 2012. When scheduling your District and County Council Conventions, please review the National and State Bylaws to ensure that your Conventions meet timeframe requirements.

This past year New York State Racing and Wagering has audited many Posts and found significant issues. If your Post has Bingo, Bell Jar or other activities under the control of the Racing and Wagering Division, please make sure that you visit their Web site and obtain the most current requirements for the activity conducted at your Post. That Web site is http://www.racing. state.ny.us/

Each year, the State Commander receives letters of concern or complaints regarding issues within various Posts throughout the State. While we are sure all of the concern or complaints are sincere and valid, there is a chain of command that must be followed before letters of concern reach Department Headquarters. The National Bylaws and Manual of Procedure Article IX provides instruction for those issues that result in disciplinary action. Post level concerns or complaints begin by presenting the problem at a Post meeting. If after presenting the issue to the Post membership there is no resolution, the County Council Commander should be contacted. Failing at the County Council level, the District Commander should be contacted with the specific details of the issue. If the District Commander cannot resolve the matter, he should forward the issues and subsequent investigation/action to the Department Commander.

It is impossible for the Department to handle the influx of letters received at Department Headquarters if the correct procedures are not followed. If you have followed the outlined steps and are still not satisfied with the results, a signed letter should be sent to Department Headquarters so the matter can be addressed as soon as possible.

Please Note: A letter of concern or complaint sent directly to National Headquarters will not speed up the process...it actually slows it down. National forwards all complaints back to the Department for review and appropriate action, thus delaying the process even more. National observes the chain of command and expects all VFW entities to do the same.

I pledge my support to the Officers and members of the Department of New York. Once again, thank you for allowing me the privilege of serving as the State Judge Advocate.

#### **Letters to the Editor**

I was kind of taken aback when I read the flag display article in the latest OS Vet.

You said the military flags are to be displayed in order of their establishment, then went on to list them incorrectly. As far as the order of establishment of the services goes, all this can be found on *Wikipedia* for those who like to discuss their views on the field, although there shouldn't be any room for argument.

Also, as there is no clear direction for civilian display, the following is the military order of precedence.

Army – 14 June, 1775; Navy – 27 March, 1794; Marine Corps. – 11 July, 1798; Coast Guard – 20 January, 1915; Air Force – 18 September, 1947. These are dates when these services were actually established as what they are. The Navy and Marines can be argued that they are older. We had no Navy, nor any money to build ships for one, but on October 13, 1775, George Washington commissioned seven ships to capture British ships. On November 10, 1775 two battalions were commissioned to serve as landing forces for this fleet. After the war, these forces were disbanded. On 4 Aug, 1790 the U.S. Revenue Cutter Service was established, which was essentially a Coast Guard. They protected the coast and captured pirates, but didn't engage at sea. On March 27, 1794, six ships were commissioned, re-establishing the Navy (the first three going into operation in 1797). The Marine Corps was formally re-established on 11 July, 1798. The U.S. Coast Guard was established on 20 Jan., 1915 with the merger of the old Revenue Cutter Service and the U.S. Lifesaving Service. The U.S. Air Force was formally established on 18 Sept., 1947 being separated from the Army.

Probably none of this means a hill of beans to a lot of people and may sound a little trite, but there are a lot of people who know enough to question, and I figured a publication such as this should have its ducks in a row for credibility, so that's why I put this out there.

We see the vets in our area using the old protocol rule that PUBLIC FLAGS outrank organizational flags, which means state, county, town and village flags outrank the MIA/POW flag. In the protocol world, the MIA/POW flag has little ranking. We see it all the time – the VFW flag outranking the MIA/POW flag.

Editor, perhaps your National VFW has the latest on flag protocol display. On holidays, we display three flags: USA, NYS and MIA/POW; it's been in that order for the past 25 years.

**Editor's Note:** Debate about flag order and correctness will not likely come to an agreeable solution any time soon and the editor takes no position on this issue, but provides data from creditable sources. The Flag Article in the Oct/Nov/Dec 2010 issue was a series of quotes and statements made in the Department of Defense Directive 1005.8...as stated in the article.

Another quote credited in the article is as follows: According to the Institute of Heraldry, and in keeping with the order in which troops are listed in Department of Defense Directive 1005.8, during peacetime the Coast Guard falls under the Department of Homeland Security. During wartime, if the Coast Guard comes under the control of the Department of Defense, then the Coast Guard flag would come before the Air Force flag in order of precedence.

# New York State Senate Veterans' Hall of Fame



Mr. William Beatty of Centereach served in the United States Army during the Korean War and is the honoree of Senator John J. Flanagan. His selection is based on the nomination from the administration of the Long Island State Veteran's Home (LISVH) in Stony Brook.

Mr. Beatty served as a Corporal in the 40th Infantry Division, 160th Infantry Regiment as part of the Regimental Combat Team and saw action in the Iron Triangle - the area in Korea bounded by Ch'orwon, Kumhwa and Pyonggang.

Following his honorable service, Mr. Beatty dedicated himself to helping other veterans, with an emphasis on those who call the Long Island State Veteran's Home in Stony Brook their home. He has been a member of the LISVH's Veterans Advisory Board since 1999 and has been its chairman for the past eight years.

For over fifteen years, Mr. Beatty has been serving as the 2nd Vice President for Korean War Veterans, Central Long Island Chapter, and he has been an active member of the Advisory Board of the Suffolk County Veterans Service Agency for the past 20 years.

Mr. Beatty's most enduring legacy to the veterans of Long Island was in the creation, development and design of the Suffolk County Gold Star Memorial in Armed Forces Plaza in Hauppauge. This memorial serves as a lasting tribute to the families that have lost a loved one in service to our country.

In addition to his work on behalf of fellow veterans, Mr. Beatty was a twenty-five year employee of the Long Island Railroad and is a dedicated volunteer to St. Margaret's of Scotland Church in Selden.

Mr. Beatty is proud to share this honor with his wife of 56 years, Veronica.





Eugene Bryant has earned a place of distinction among the State of New York's Veterans in recognition of his meritorious military service and his tireless advocacy on behalf of his fellow veterans. Mr. Bryant served his nation admirably in two separate branches of the United States military during the Vietnam War. He

served the United States Army from 1959-1960 in Vietnam, where he attained the rank of Corporal; and then again, in the United States Marine Corp from 1961-1964 in Vietnam, attaining the rank of Sergeant and serving two tours.

During his military service to our country, he received the National Defense Service Medal, the Vietnam Service Medal, the Vietnam Campaign Medal with 2 O/S Bars and a Good Conduct Medal.

Mr. Bryant, an active advocate for veteran's issues, has diligently served veteran's causes in many VFW capacities and committees, including: National Deputy Chief of Staff, National Aide-De-Camp, Chairman of N.Y. State Homeless Vet, Vice Chairman of N.Y. State Membership, All-State Post Commander, Commander of District Two, All-State County Commander, Westchester County Chaplain and Quartermaster, Advisory Committee Chairman of Westchester County, a Member of the Legislative Committee and Chairman of the Agent Orange Committee.

Currently, he is the Post Commander of the Aaron A.

Lewis VFW Post 6396 in Mount Vernon.

In addition to his VFW interests, Mr. Bryant also serves as the President of the Huguenot Lions Club of New Rochelle, is a member of the New Rochelle Waterfront Advisory Committee and coaches for the New Rochelle Youth Tackle League.

In addition to his many civic and VFW interests, Eugene enjoys many hobbies and spending time with his wife of 50 years, Nannie Bryant, his children and grandchildren. Commander Bryant is so dedicated to serving his fellow veterans, that he is lovingly known to his family as the "veteran's veteran."

Michael Burke was born on September 4, 1949. After graduating from Wyandanch Memorial High School in 1968, he worked for Chase Manhattan Bank in New York City, until he was drafted into the United States Army in April 1969.

During his time with the Army, Michael was sent to Vietnam in

October of 1969. While on tour, he was wounded twice. His first injury occurred in Vietnam and he returned to duty, being injured again in Cambodia on May 8, 1970, which ended his tour. After sustaining significant injuries in Cambodia, Michael spent one week in a hospital in Vietnam and was transferred to a hospital in Japan for a month. His final recuperative stay was a six month period at the Walter Reed Medical Center in Washington, D.C. He received two Purple Hearts, a Bronze Star with 'v" device, an Army Commendation Medal with 'v" device for heroism, a Vietnamese Service Medal, Republic of Vietnam Campaign Medal, Conspicuous Service Star, Combat Infantry Badge and the National Defense Service Medal.

Upon his retirement from the Army, Michael returned to Wyandanch and married his lovely wife, Juana, on October 13, 1973. While attending Marist College, he and his wife raised their five children: Jayne, Michelle, Melissa, Michael, Jr., and Marland Burke. Michael went on to have a successful career at IBM, and retired after

Michael Burke has held numerous prestigious positions for the Veterans of Foreign Wars. He currently serves as Post Commander for the VFW Valil Wolff/McKenna Frye Post 170 in Poughkeepsie, New York and is also District Commander for District 2.

Karl R. Rohde is a highly-decorated Vietnam combat veteran of the United States Army, a dedicated servant of his community and a resident of Carmel, New York. He and his wife of 37 years, Irene, have two children, Dori and Karl W.; twin grandsons, Andrew and Robert Rohde; and a granddaughter, Olivia

Venezia. Karl holds two Masters degrees in American History and Secondary Education, is a Town Councilman for Kent and is the Putnam County Historian. After 28 years, he retired from Local 1103 Communications Workers of America, where he worked as Union Job Steward.

For his service to our nation, Karl has received the

Silver Star, Combat Infantry Badge, M-16 Expert Rifleman Award, Army Commendation Medal, Vietnam Service Medal, Vietnam Campaign Ribbon, Good Conduct Medal, Vietnamese Cross of Gallantry and the New York State Conspicuous Service Cross.

As a member of the Veterans of Foreign Wars (VFW), The American Legion, AMVETS, Benevolent and Protective Order of Elks, Military Order of the Cootie, Americal Division Veterans Association, The 40 & 8, Vietnam Veterans of America and Marine Corps League, Karl is among the most prominent and active veterans of the Hudson Valley. He is also the founding Chairman and present Vice Chairman of the Putnam County Joint Veterans Council, as well as the Chairman of the Putnam County Veterans Memorial Park Advisory Committee.

In his capacity for the VFW, Karl currently serves as State Quartermaster. 

# **A New Course for College and Career Success**

Recently, the Success Strategies for Military and Veterans (CCS 112) course was launched at Excelsior College. This new online course provides active duty service members, transitioning military members, service members in reserve or guard components and veterans the tools for college and career success. Judy Reed, Director of Veteran Services and Outreach, and Maribeth Gunner, Career Services Coordinator, combined efforts to create a course specifically for Excelsior students with a military background as an introduction to college and a springboard to career transitioning from the military environment to the civilian workforce.

Students benefit in many ways during this eight-week course and earn three college credits. Students learn about the numerous support services that Excelsior College has available to assist them in being successful students. There is a review and full assessment of their military education and training used to reach degree goals most efficiently.

Students participate in self-assessment activities and learn where to access valuable career and education planning resources. The results of assessment activities aid students researching career fields of interest and corresponding education requirements, which culminates into building their personal education plan. Next, students become familiar with additional tools to explore how employment trends, job outlooks and other factors can influence their career paths. After reviewing decision-making models and goal setting techniques, students build their own personal career action plans that will guide future goals. Military and veteran students also gain knowledge on various job search strategies, including those specific to the military and veteran populations.

There is a Success Strategies for Military and Veterans online course convening every other month. Many of the military and veteran students have found higher level degrees and certificates they are planning to pursue, once they meet their current education goals. Both Maribeth Gunner and Judy Reed agree that the course will assists students in adequately preparing for academic success and career planning for both military and civilian careers. The current students are actively engaged in this course, learning to use the tools for the achievement of college degrees and the investigation of their future career paths.

Sometimes it's nice to read about one of our own. The following is about Ted Cohen, a member of Staten Island's Anderson-Lagno VFW Post 5090. Ted is active assisting Post efforts outreaching to local Veterans, in support of active-duty troops, as well as youth and school programs. He's also a member of Staten Island's Watkins-Kellett American Legion Post 277.

Ted resides in Eltingville on Staten Island's south shore along with his wife of 51 years, Janice. They have a daughter and two grandsons (15 and 11) who live in Georgia. Their oldest grandson is very interested in attending a service academy and both boys are Georgia State-Level competitive swimmers.

As Ted states: "The scenario was Air Force ROTC cadet training, which was required in order to be commissioned. I received my Second Lieutenant's bar in June 1959 through the Brooklyn College AFROTC program.

Greenville AFB, Mississippi, was an old WWII single engine aircraft training base for pilots and aircrews. We lived in open bay wooden barracks, and were put through rigorous physical/mental abuse, which was par for the course. The scariest part was the "jump school", where you had to plummet from the 60 foot tower in the parachute harness, and then roll on the landing. I made it okay, and was lucky not to break anything. But, at 19 years of age, I was indestructible, as were we all. In my 5 years of active duty with USAF, I never had to bail out. Thank God.

The aircraft shown in the photo was the T-33 single engine jet trainer which was a modified F-80 Lockheed Shooting Star. It went into service around 1948, and was one of the earliest fighters used in Korea, prior to the better known F-86 Sabrejet. The T-33/F-80 was a great airplane, and was quite forgiving of mistakes by rookies.

With my typical lousy luck, I was assigned to Strategic Air Command (SAC) for the entire five years (1959-1964). I never again got into single engine planes, except for some time in the L-20 DeHavilland Beaver observation plane, which was lots of fun.

In SAC, I was initially in 16th Air Force in southern Spain with B-47 medium Bombers. That was 1959-1962. Then I was sent to Pease Air Force Base, New Hampshire, again in B-47's from 1962-1964. The 8th Air Force unit at Pease was the 509th Bomb Wing...noteworthy as the only group permitted to wear the "mushroom cloud" patch. It had been the Wing that dropped the nuclear bombs on Japan in 1945.

The most memorable experience at Pease was the Cuban Missile Crisis in October 1962, which was very terrifying. We had nuclear weapons on board and were sitting on the runway for almost 24 hours, ready to go. We were a backup unit to the SAC B-52 fleet, and would only have been ordered to fly had there been problems with any primary B-52 units. Thankfully, we finally were ordered to stand down. I often think about the consequences had we completed our mission to bomb Cuba. We might not even be here to talk about it.

In 1964, I decided to get out and resigned my Regular Commission as a Captain. I went into the NY Air National Guard in 1969, but that's another story. Upon release from USAF active duty in 1964, I worked in management for the *New York Daily News* for 5 years. In 1969, I accepted a marketing position with Avon Products World Headquarters in New York City. In 1994, I retired as Manager of International Marketing and traveled extensively throughout Europe, Latin America and Asia. I'm also fluent in Spanish.

In 1973, I earned an MBA degree from Fordham University Graduate School of Business.

From 1969-1975, I served with New York Air National Guard, 106th Combat Support Group, initially stationed at Floyd Bennett Field, Brooklyn, New York and later at Suffolk County Airport, Westhampton Beach, New York.

My retirement activities include financial consulting, politics, antique collecting and fishing."

# VA Expands Outreach to Women Veterans Department Hosts 5th National Summit in D.C.

WASHINGTON (July 15, 2011) – Over 700 participants plan to attend the Fifth National Summit on Women Veterans' Issues scheduled July 16-17 at the Hyatt Regency-Washington on Capitol Hill. Secretary of Veterans Affairs Eric K. Shinseki will give remarks to open the summit, which will focus on expanding outreach to women Veterans and increasing awareness of the enhanced VA benefits and services available to them.

"With more women serving in our armed forces than ever before, this summit is an opportunity to exchange ideas and focus attention on the issues and concerns unique to women Veterans," Shinseki said. "Today, there are over 1.8 million women Veterans of all eras and one of VA's highest priorities is to continue to expand our services and outreach to ensure they receive the care and benefits they have earned."

This is the first time VA will provide targeted training, education, and collaborative cross training for its staff responsible for providing services and benefits, specifically to women Veterans and their families. Participants

include: women Veterans, women Veteran advocates from across the nation, active duty women service members (to include those in the Reserves and National Guard) VA employees who provide care to women Veterans, and representatives from a multitude of Veterans service organizations and nonprofit agencies. VA Medical Centers employ women Veterans program managers; community-based outpatient clinics employ a women's liaison; and VA regional offices employ a women Veterans coordinator.

"The number of women Veterans using VA health care has doubled in the last decade," said Patricia Hayes, chief consultant of VA's Women Veterans Health Strategic Health Care Group. "This training, coupled with direct feedback from women Veterans, will enable VA to continue to enhance health care and services to meet their needs."

Today, over 200,000 women are serving in the armed forces. About 11 percent of the U.S. forces currently serving in Afghanistan and Iraq are women. Recognizing

the valor, service and sacrifice of America's 1.7 million women Veterans, VA has stepped up its outreach efforts to women Veterans to increase their awareness of the comprehensive array of VA benefits and programs. Women Veterans are entitled to the same benefits and medical care as their male counterparts, including health care, disability compensation, education assistance, work-study allowance, vocational rehabilitation, employment and counseling services, insurance, home loan benefits, nursing home care, survivor benefits and various burial benefits.

In addition, VA also has a multitude of gender-specific services and programs that respond to the unique needs of women Veterans, including pap smears, mammography, general reproductive health care, counseling for substance abuse, sexual trauma, depression and evaluation and treatment for Post-Traumatic Stress Disorder (PTSD). # **VFW Joins in Houston National Cemetery Censorship Lawsuit**

KANSAS CITY, MO, July 1, 2011 – The National Commander of America's largest and oldest major combat veterans' organization is appalled over allegations of religious censorship at one of the nation's national cemeteries, calling it a case of "bureaucracy running amok."

"This is a point in case of bureaucracy...or rather, a classic example of a bureaucrat running amok. In spite of VA policy, the cemetery director is making up her own rules and has imposed hurtful, unilateral restrictions of her own choosing," said Richard L. Eubank, the National Commander of the 2.1 million-member Veterans of Foreign Wars of the U.S. and its Auxiliaries.

Texas-based Liberty Institute has filed suit on behalf of the VFW, American Legion, and The National Memorial Ladies over allegations of religious hostility and unlawful censorship by the VA and its director of the Houston National Cemetery. "They've told the VFW and the American Legion that they cannot have prayer during the burial services of our veterans, unless the family requests it in writing and submits the prayer for pre-approval," said Liberty Institute general counsel Jeff Mateer.

The VA, meanwhile, insists its national cemeteries welcome appropriate religious recitations. The "VA values and respects every veteran and their family's right to a burial service that honors their faith tradition," said Keith Ethridge, director of VA's National Chaplain Center. The Houston cemetery superintendent has declined to speak to the media, despite numerous requests.

"Generations of patriotic Americans have fought, bled and died to help defend the U.S. Constitution – that great document provides and guarantees fundamental rights of religious expression and freedom of speech. Those basic tenets are clearly being violated at the cemetery and that simply cannot be tolerated," concluded Eubank.
