Once again we would like to remind you each year the State Commander receives letters of concerns or complaints regarding issues within various posts throughout the State. While we are sure all of the concern or complaints are sincere and valid, there is a chain of command that must be followed before these letters reach Department Headquarters. The National By-Laws and Manual of Procedure Article IX provide instruction for those issues that result in disciplinary action. Post-level concerns or complaints begin by presenting the problem at a Post meeting. If after presenting the issue to the Post membership no resolution can be

reached follow the steps outlined in Article IX. It is impossible to address the influx of letters received at Department Headquarters if the correct procedures are not followed. Following the steps outlined in Article IX should bring the issue to the appropriate level of the VFW for resolution.

PLEASE NOTE: Α LETTER OF CONCERN OR COMPLAINT SENT DIRECTLY TO NATIONAL HEADQUARTERS WILL NOT SPEED UP THE PROCESS. IT ACTUALLY **SLOWS** IT DOWN. **NATIONAL** FORWARDS ALL COMPLAINTS BACK TO THE DEPARTMENT FOR REVIEW AND APPROPRIATE ACTION THUS DELAYING THE PROCESS EVEN MORE. NATIONAL OBSERVES THE CHAIN OF COMMAND AND EXPECTS ALL VFW ENTITIES TO DO THE SAME.

At the 115th National Conventions the Delegates passed many minor changes to the National By-Laws and Manual of Procedures. The most controversial resolution passed was for the Adjutant General and the National Secretary Treasurer to propose a By-Law that would establish one Auxiliary to the VFW for next year's National Convention for the VFW Membership to Vote on.

I pledge my support to the Officers and members of the Department of New York. Once again, thank you for allowing me the privilege of serving as the State Judge Advocate.

I want to thank Department Commander Schmitz for the re-assignment as this year's Department Chair of Patriot's Pen Youth Essay Contest. I encourage all Post and District Chairman to please co-ordinate your efforts with your Ladies Auxiliary counterpart.

All information that is needed for Chairmen to conduct the 2014-2015 Patriot's Pen Program is online now under "My VFW." Visit the VFW website www. vfw.org where you must LOG IN (or create an account and LOG IN). Under the General Members Tools and Resources heading, click on CHAIRMAN GUIDES, where you will find the "Scholarship Programs" manual that covers both the Voice of Democracy and Patriot's Pen programs. Listed below that manual, you will find additional brochures, along with other materials and resources. Anyone (including chairmen, student entrants, and teachers) can download and print the student entry forms for Patriot's Pen by visiting, www. vfw.org click on COMMUNITY, and then YOUTH AND EDUCATION.

Post Chairmen need to copy and provide each student with a Patriot's Pen brochure/entry form directly or through the teacher or youth leader. To participate in the Patriot's Pen contest, a student needs to submit a completed entry form and their essay of 300 to 400 words in length {essays of too many or too few words are eliminated.} Students should have ready a clear, close up, head and shoulders picture, to be sent in only if

they become a District Winner. This year's 2014-2015 Patriot's Pen theme is: "Why I Appreciate America's Veterans."

All student entries are due at the Post level by midnight, November 1, 2014. Your Post judging should be done by November 15, 2014. You need to pass your winners on to your District Chairman right away. I am asking all District Chairmen to have their judging completed by December 8, 2014, after which time the winning District entry will be submitted to the Department chairman. The Department judging will be held at the Malsan-Jones VFW Post #7393 during the week of December 15, 2014.



HONORING MR. HARRY WURTH

Hon. Steve Israel OF NEW YORK

Mr. Speaker, I rise today to honor the memory of Mr. Harry Wurth, an esteemed citizen of my congressional district who committed his life to his country and to his fellow veterans. Mr. Wurth, a longtime resident of Albertson, NY, passed away on June 14, 2014 at the age of 87. A veteran of World War II and a leader of the United States Veterans of Foreign Wars Department of New York, Mr. Wurth's life was an example of what it means to serve one's nation.

After graduating high school in 1945, Mr. Wurth enlisted in the Navy and was deployed to the Pacific Theatre toward the end of the war. Aboard the aircraft carrier, the U.S.S. Belleau, he served as deck crew and later as a baker. He was honorably discharged at the end of the war.

Mr. Wurth committed the remainder of his life to serving New York veterans. In 1964 he joined the Veterans of Foreign Wars Post 3211 in Hicksville, New York, and rose to Post Commander in 1969 and All State Commander. A frequent visitor to VA hospitals in Northport and St. Albans, New York, in 1972 he was elected Chaplin to the Nassau County VFW Council.

Mr. Wurth continued his dedication to the VFW in various positions on the Nassau County and State level. He was elected Chaplin and Commander of VFW District 1 in 1978, and in 1981 he transferred to the Albertson VFW Post 5253. Rising to New York State VFW Chief of Staff in 1993, Mr. Wurth led the effort to establish 19 new Veterans' Posts in New York.

From 1994 to 1996 he continued to move up the ranks in the State Council, rising to VFW State Commander. At the time of his passing, Mr. Wurth was the Quartermaster for the Albertson VFW post and Quartermaster of the Nassau County VFW Council.

Mr. Wurth passed away while attending this year's NY State VFW Convention. Until his death, Mr. Wurth never ceased serving our country and veterans alike. I am honored to have had the pleasure to serve as Mr. Wurth's representative. His life will forever be remembered as one of service and commitment to his fellow countrymen.



DEPARTMENT OF NEW YORK, VETERANS OF FOREIGN WARS OPPOSES THE "SAFE ACT"... <u>Supports its Repeal!</u>

The Second Amendment to the United States Constitution protects the right of individuals to keep and bear arms. The Supreme Court of the United States has ruled that the right vests in individuals, not merely collective militias, while also ruling that the right is not unlimited and does not prohibit all regulation of either firearms or similar devices. State and local governments are limited to the same extent as the

federal government from infringing this right per the incorporation of the Bill of Rights. The Second Amendment was adopted on December 15, 1791, as part of the first ten amendments comprising the Bill of Rights.

Military personnel, public servants and elected officials are required to swear an oath to support the constitution of the United States as well as the New York State constitution. The fourth federal law, 18 U.S.C. 1918 provides penalties for violation of oath office described in 5 U.S.C. 7311 which include: (1) removal from office and; (2) confinement or a fine. As veterans the oath is eternal and in defense of the constitution we regard this action unconstitutional and a violation of federal law not to mention a moral degradation. The passage of the SAFE ACT is a disgrace and the ultimate insult to all those who gave their last full measure in defense of the constitution.

That the Department of New York Veterans of Foreign Wars go on record as Second Amendment to the United States Constitution and denounce the "Safe Act" as a circumvention of the Constitution that the law be revisited by law makers with public input.
