#### Comrades,

As we near the State Convention it is my duty as Judge Advocate to bring to your attention the following requirements of the National By-Laws and Manual of Procedure as

it relates to Arrearages, Deficiencies and Omissions. The Post Commander is to ensure that all obligations of the Post are completed and submitted to the County Council, District, Department and National as required by Section 213 of the National By-Laws and Manual of Procedure:

## National By-Law - Sec. 213—Arrearages, Deficiencies and Omissions.

Any Post in arrears for any financial obligations to County Council (if applicable), District, Department and National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in County Council meetings (if applicable), District, Department and


I want to share with you the history of a fraternal organization comprised of American veterans linked through their experiences of war.

They had come together in camaraderie and it lead to other positive reasons, like maintaining connection with each other, networking and giving veterans a voice.

This group of veterans grew into hundreds of post all across America and having a mission that included supporting voting rights, promoting patriotic education, helping to establish national holidays, lobbying Congress to establish veterans' pension and became very strong in supporting political candidates. This well recognized advocacy group enjoyed growth with posts in every state and some over-seas. They even became a political power to the point that presidential candidates couldn't get nominated until they had the endorsement of this veterans group. Five presidents between 1869 and 1897 owe their nominations and subsequent elections to them. They had well attended "Encampments" or conventions at both the state and national levels were presidential nominees were known to have attended.

Does any of this sound familiar?? Let me finish their story...

## **Brian J. Duffy** Junior Vice Commander-in-Chief Veterans of Foreign Wars of the United States

Brian J. Duffy was elected as Junior Vice Commander-in-Chief of the Veterans of Foreign Wars on July 23, 2014, at the VFW's 115th National Convention, held in St. Louis, Mo.

Mr. Duffy served in the U.S. Air Force as a Jet Engine Mechanic on F-4 "Phantom" fighter aircraft, and later transitioned and served as a Flight Engineer on the C-141 "Starlifter" transport aircraft. He deployed in support of several campaigns, to include Grenada, Panama and Desert Shield/Storm, and among his numerous military decorations are the Air Medal, an Air Force Commendation Medal, the Armed Forces Expeditionary Medal, the Southwest Asia Service Medal and Kuwait Liberation Medal. Upon returning from Grenada in 1983, he joined VFW Post 6590 in Cookstown, NJ, but later transferred his membership to VFW Post 1170 in Middletown, KY., in 1989. Following his military service, he was employed by several airlines as a Flight Engineer Instructor before joining United Parcel Service Airlines, where he rose through the ranks and would retire as Assistant Chief Pilot of UPS, after flying worldwide as an Instructor/Check Captain on the Boeing 757 and Boeing 767 aircraft.

When not in the cockpit, he enjoys playing competitive ice hockey and serving fellow veterans and military

through numerous volunteer programs with the VFW, Honor Flight, and recovering warrior projects.

In 2006, Mr. Duffy was elected Commander of the VFW Department of Kentucky, and has achieved All-American status at Post, District and State levels. His Honor Flight activities have been recognized throughout the Louisville community, to include the Kentucky Derby Festival and the Kentucky Aviation Hall of Fame. In 2012, he was the recipient of President Obama's Volunteer Service Award, after being nominated by UPS to recognize his volunteer activities. Mr. Duffy is a VFW Gold Legacy Life Member, as well as a member of the VFW National Home for Children, the Military Order of the Cooties, the American Legion and AMVETS. He and his wife, Jean, who serves as the VFW Post 1170 Ladies Auxiliary President, reside in Louisville, and have two adult children, Tara and Andrew.



## Gene Ratigliano State Inspector



As we move past the halfway mark in this VFW year and almost reaching the three-quarter mark, many posts within the Department still have not been inspected. A review

of the Memstats reveals that a number of posts have reached or exceeded their 100% in membership but have not submitted one Trustee Report of Audit and in some cases not a single Community Activity Report as well as not having been inspected or completing an IRS 990 for the year. It seems that Post Inspectors will be hard pressed to complete their post inspections prior to the drop dead date of May 2, 2015 in order to meet the State Commander's requirements to become eligible for the All State Commander's Award and white hat. Equally critical is the completion of the Post's requirement to have their Post Service Officer trained by April 15, 2015 to meet eligibility.

Post inspections are an integral part of a posts oversight program to ensure the financial integrity of member's post assets. Quarterly review of the posts financial management processes through the use of the Trustee Report of Audit and financial bonding become part of the protection umbrella in protecting member's financial assets. Failure to complete the required Trustee Report of Audit quarterly and prepare it correctly voids in most cases any bond that may be in place because insurers of the bond will in all likelihood not pay for any loss due to the negligence caused by the failure of the Post Trustees to adequately oversee the financial assets placed in their charge.

Inspection reports received in the Department continue to be received with questions unanswered and required documentation not verified as part of the inspection process. Too many Quarterly Trustee Reports of Audit are received poorly prepared with inaccurate information, blocks left blank, bonding information and required signatures missing. Post Quartermasters who purchase pads of the Trustee Report of Audit form the VFW Store will have the detailed preparation instruction for the audit printed on the back of the form. I will be working closely with the CIT Director to have the instructions posted to the Department website in the forms section for easy download to assist Post Trustees in the proper preparation of the audit.

Five non-profit veterans organizations (four which are VFW posts) in upstate NY have been notified of upcoming IRS compliance audits that will be taking place over the next month or so. Whether the IRS will be visiting other posts in the state is yet to be determined but be prepared. The questions being asked on the Post Inspection Form are part and parcel to the documentation being requested by these posts as part of their compliance audits.

Notification letters being received by the selected posts are being notified to have the following documents available as part of the audit: governing instruments which include Article of Incorporation, By-Laws, Code of Regulations, copy of letter granting exemption from income tax received from the IRS, minute books showing recorded meetings of your governing body (Officers, Directors or Trustees) including committees, copy of newspapers, newsletters, brochures and other printed literature, any contracts or leases to which the post/organization was a party to and documents which explain rental contracts. In order to verify the correctness of income, gross receipts, deduction and credits books and records of the post/ organization's assets, liabilities, receipts and disbursements including the general ledger, annual financial statements etc. are required to be made available. Employee earnings records are also being requested.

If your post still needs to be inspected, please make arrangements at the earliest with your County Council Commander or District Commander to schedule a date to have it completed. Do not look upon the post inspection as a harbinger of doom but an opportunity to increase your knowledge of how post administrative requirements should be completed. Your inspector is one who has been around the block and should be knowledgeable to provide you the answers to many of your questions of how things should be done. If he or she does not, they know how to get the answers to your questions. Use your inspection as a training opportunity and make it a positive event, not a negative one.

## Bob Barnhart State Quartermaster



In my years as State Quartermaster I have not seen so much IRS activity involving veterans' organizations like the VFW, American Legion, Amvets and so on as I've seen

in the past year or so. For the past two or three years I have been warning posts that they should be putting their house in order or they could lose their tax exemption status because they forgot to report an activity or sale. I have been urging post officers to take their responsibilities seriously and follow the laws or suffer the consequences, but few have taken me seriously.

Even though I have reported certain VFW posts were fined thousands of dollars and/or losing their tax exempt status most thought I was crazy and making things look worse that they really were. So now we are facing a serious threat to our purpose as a veterans' organization because of so much greed and refusal to believe the warnings I have been sending out.

The IRS is conducting compliance audits at VFW and American Legion Posts all over the state. It appears the IRS has started in the western part of the state but now the word is out they have been looking at posts in the Saratoga area.

Glens Falls just had their IRS audit completed and what they looked at were quarterly bell jar filings, the percentage of the membership who were considered veterans and the review of DD-214's. I am informed the post refused to produce the DD-214's and the IRS did not peruse the issue but I am also informed the IRS is pushing the DD-214 issue with certain American Legion posts for some reason and denying some exemptions and allowances because they don't feel some recorded members qualify for membership. This is a serious issue and we need to be aware that the government is looking at our membership lists to make sure they qualify for VFW membership, which has more stringent requirements.

They may be looking for unreported business income such as the rental of halls, and other venues that the post may have and whether they are rented to members or to the public. 990's have also been in the spotlight

them before problems at their post get bad." "we could teach them how to do community service reports and why we do them." "THERE WAS NO WAY TO INSIST THAT POSTS ATTEND ANYTHING, EXCEPT DISTRICT MEETINGS," we are told.

Finally, after years of neglect, the VFW is insisting every Post and District follow the by-laws by having post representation at every District meeting. That is a *mandatory* requirement with no exclusions! After much uproar and furor we persisted and will continue to persist and insist every post be represented at their district meetings. Now we are receiving word that many districts have every seat filled and every post attending regular district meetings. Now we see that every post is informed, no excuses, no more "I didn't know." or "No one told me." There are fewer calls to Headquarters about not knowing and/or understanding what is going on. Maybe now we will see results, success and accomplishments.

Now that we have the attendance we can begin to educate and communicate at District meetings. It is up to the District leadership to insure that education takes place at these meetings, and the attending members need to let them know what areas they would like

National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

There has been much discussion about making changes/amendments to the Department and National By-Laws. For a change or amendment to the Department or National By-Laws to be considered and voted on by the Delegates present at this year's State Convention the Resolution in proper form. Please follow the instructions provided in the Department By-Laws in regard to this matter.

#### Department of New York By-Laws ARTICLE X Resolutions

Sec. 1.00 (A) All resolutions must be typewritten and submitted in triplicate, in order to receive consideration at the Department Convention. (B) Post under the jurisdiction of a County Council shall clear their resolution through their Council. (C) All resolutions to be considered by a Department Convention shall be in the hands of the State Adjutant at least fifteen (15) days prior to the convening Convention date, except resolutions proposing amendments to the By-Laws of the Department shall be delivered to the State Adjutant not later than thirty (30) days before the opening date of the Convention, and the State Adjutant shall mail a copy of all proposed amendments, at least fifteen (15) days before the Convention to all State Officers, Past State Commanders, District Commanders, County Council Commanders and Post Commanders, and unless this section is complied with no resolutions shall be considered.

Sec. 2.00 All resolutions (other than emergency) forwarded to the Department for action, from any unit, shall contain a certification signed by the Adjutant, in the following form: I hereby certify that the foregoing resolution was considered and.....\*adopted at a meeting of...held on the...day of..., 20...,according to an entry in the minutes of said meeting.

Dated....., 20.

Adjutant

(All other spaces should be filled. \*Insert word "not" if required)

Sec. 3.00 All units shall forward to State Headquarters for consideration, all resolutions introduced at its meetings by a subordinate unit, if certifying whether it was or was not adopted by the major unit, if the resolution requires action on a Department or National basis.

Sec. 3.01 No resolution may be passed, approved, or adopted at any Convention of this Department, or any meeting of the Council of Administration of this Department, unless same is limited to one subject, and said subject must be expressed in the title.

Sec. 3.02 All resolutions submitted to any meeting of a Department Convention or meeting of the Council of Administration of this Department, shall receive a number immediately upon receipt, in numerical sequence, without the addition of any fractional number.

**Posts, County Councils and Districts time for change.** If you have no By-Laws or have not updated your respective By-Laws within the last 10 year it is time to do so. Why? These have been many changes to the National By-Laws and Manual of Procedure which effect the operation of our Great organization at all levels. For those who are developing their By-Laws for the first time we have a template located on the Department WEB Site under the Department of New York Tab, Forms, and scroll all the way down to By-Law Template.

We would like to remind you each year the State Commander receives letters of concerns or complaints regarding issues within various posts throughout the State. While we are sure all of the concern or complaints are sincere and valid, there is a chain of command that must be followed before these letters reach Department Headquarters. The National By-Laws and Manual of Procedure Article IX provide instruction for those issues that result in disciplinary action. Post-level concerns or complaints begin by presenting the problem at a Post meeting. If after presenting the issue to the Post membership no resolution can be reached, follow the steps outlined in Article IX. It is impossible to address the influx of letters received at Department Headquarters if the correct procedures are not followed. Following the steps outlined in Article IX should bring the issue to the appropriate level of the VFW for resolution.

**PLEASE NOTE:** A letter of concern or complaint sent directly to national headquarters will not speed up the process. it actually slows it down. national forwards all complaints back to the department for review and appropriate action thus delaying the process even more. national observes the chain of command and expects all vfw entities to do the same.

Once again, thank you for allowing me the privilege of serving as the State Judge Advocate.

Unfortunately their mission became ill defined and they floundered, almost to the point of disappearing, with many departments and local posts ceasing to exist. Recognizing the situation they were in, there was a revival under new leadership that renewed their growth, but this lasted for only so long because the membership eligibility had been narrow and over time the members were dying or were no longer able to participate in activities leaving no choice for posts but to consolidate or disband all together. They ceased to exist when the last member died.

Do you know who I am telling you about? Are you thinking this my story of the VFW? There are a lot of similarities, but the truth is it is the history of the Grand Army Republic or G.A.R. They were a very early on veterans' advocacy group that existed from 1866 to 1956 – a total of just 90 years. They peaked in membership in 1890 (about a third into their existence) and experienced a rather steady decline shortly afterward.

The truth is that the VFW started in 1899, and had modeled themselves after the G.A.R in terms of posts, departments and national level structure. At that time our mission ran close to what the G.A.R was doing and both existed side by side for 57 years. Unfortunately the similarities don't end there.

We do have some differences: While the G.A.R. had narrow membership eligibility of just Civil War veterans, the V.F.W. has a wide membership eligibility of all wars. The V.F.W.'s problem is narrow-mindedness...with the inability to accept new members because of age, gender, and ethnicity or the inability to accept change for the betterment of the organization or even the unwillingness to be out doing community activities, whether due to age or complacency are all contributing factors to ensuring our closing date. While I realize that it is certainly not true in every post, the ones that this does apply to outweigh the ones that it does not. Before you proclaim "Not my post!" ask yourself a few questions:

Who is the newest member of your post? Have you seen them in the last year?

What was your last community activity? Do you participate?

Who was the last veteran or family of a veteran you helped directly? How long ago?

Who is the youngest member of your post? If they are in their 70s, 80s or 90s, why?

We do have one other difference...we have not closed with the death of our last member, but mathematically we are not far from it.

Our peak membership was 2.1 million. From 2002 to 2014(22 years in time) we lost 800,000 members = 36,363/yr.

Current membership is 1.3 million. If we continue at the same rate of loss (like the G.A.R. did) we could be closing the V.F.W. in 35 years = 2049.

I don't think the masses understand the urgency of our situation!!! Of course, we are not a "last man standing" organization and the ages of some of our members are only in their 20s (if they stay), so the variable in all of this is **US**!!

Are we going to change enough to be relevant to the newest generation of veterans, not in the future, but NOW!

Are we willing to listen to what they see as their V.F.W. and help them obtain that goal to ensure the V.F.W. for decades to come <u>or</u> are you satisfied with what **you** got out of this organization and are willing to contribute to the 2049 Closing Date?

I, for one, am in it for the long haul....will you be joining me?

for several years and the IRS is hammering away at veteran's posts to comply or sacrifice their tax exempt status. More than one post has ignored my warnings or made excuses for not filing as usual and are paying a steep price for their arrogance.

When the tax exempt status is lost it costs posts a fortune in donations and other revenues and is almost impossible to get that status back. From that point on every penny is taxed and there is no room for error after that making a post's existence almost impossible.

Posts general files are reviewed as well in a usual two-day audit process. Whether each auditor is looking at the same items or not has not been determined and each auditor is a different person so they may all have a different agenda when they visit. With that in mind every aspect of post income and record keeping must be in order and up-to-date. Excuses like not having the time, I'm a volunteer, or we didn't know just don't wash with the IRS, they are out for your ass...ets and nothing will make them back off.

My goal has always been to keep posts informed and up to date with governmental requirements and rules. Ignoring the issues doesn't make them go away, it just makes things so much worse. Searching out those thieves that would steal from veterans has been a non-stop job since being the State Quartermaster and it appears there is little I can do to stem the tide of destruction of those determined to use their posts as their personal bank accounts.

When officers take the oath of office they are admonished to follow the by-laws and the laws of the country. Taking that oath for granted is the downfall of so many posts and officers I've started to lose count. More than one greedy officer is serving time in prison and jail today because they assumed the post monies belonged to them and felt they were above the law or shielded from it. Being a VFW entity doesn't shield anyone, we are all responsible for our actions and we are accountable to the government and our members for everything we do.

Many adult learners returning to college for a degree struggle to strike the right balance between home, work, and study. On that point, Excelsior College student and Marine veteran Ed Morneault is similar to millions of other post-traditional students.

become a college professor.

He's on the right path. Over the past year, Ed has maintained a 4.0 GPA. Ed has also taken on the role of counseling three new veteran students on time management, education benefits, study skills, and more as a veteran mentor through an innovative new initiative within the Center for Military Education. He's also become the patient advocate at his dialysis unit, helping to answer questions and represent the needs of those undergoing treatment.

Ed has overcome tremendous odds to be where he is today, while excelling both academically and professionally, and still finding the time to impact the lives of others.
