Comrades,



Commander and Line Officers for resolution.

Further, we must encourage those Posts that have not attended OTI in a couple of years to attend as the By-Laws change every year and they can contact those who could be a resource in the future. I suggested that the District Commanders continue to share their OTI dates so that each could maximize the effect of the training.

Simply stated, the Department Line Officers and Membership Team need to be more visible at the Post, County Council, and District meetings.

Reminder: VFW Posts may change their Quartermasters this year. The IRS requires that the all new Quartermasters file IRS Form 8822-B within 60 days of taking office. This form provides the Quartermaster's current contact information and current address in the event that the IRS sends notifications and/or contact the Quartermaster. There is a link on the Department website to down load the IRS Form 8822-B.

to happen. As all of this is new, I must make it clear that there is no Department "program" that I'm aware of to "save Posts". However, there may be ideas to help or other possibilities.

Speaking of communications for me personally, I am finding out just how poorly our VFW "communication system" works. There has been a ton of information put out by Department. One group will tell you too much, another will say not enough, or they didn't get any. This is mainly because we currently rely on the "chain of commander" to disseminate. Most, if not all, of the District Commanders do very well with passing this information on, with hopes that they have all the email addresses of the Post leaders which, many times they don't. There are too many post leaders who will not share their contact information. It is very important that the senior leadership of Posts provide an email address on their election report. Even if you must create a new address dedicated to VFW matters so that your personal email isn't forever "out there". By the publication of this newsletter, all election reports should have been filed. Your Quartermaster can, however, get into the report again for updates. These updates may not be totally reflected this year, but it would help. If you have accepted a leadership position, you should want to get all the information possible to make your post current with all that transpires.

On the other side of the communication coin, we at the department level have found additional and better ways to communicate amongst ourselves. We are now talking to the senior staff at least once a week and the Committee of Administration also "meets" more often. In future Department conventions you will see many updates and changes to our By-laws. There is no way to say what those will be specifically at this time because a committee has not been announced yet. Being able to conduct business in different, additional ways than we are used to, will certainly be on the agenda.

I am one who believes that, for our organization to be the most effective in addition to telecommunication ideas, we need to have occasions where we do meet as groups at our various levels. We need to share experiences, learn from each other, make sure we are all getting the same messages and maintain our comradery and friendships, which are key. I would hope that we never get to the point where we all know each other from ZOOM, Facebook live etc., but we do need to have other options available when needed and applicable.

I look forward to getting to our "new normal" and working with each of you to make our VFW an even more effective and strong organization, who does more for VETERANS.

I think using these modern conveniences will also help us to attract quite a few of the younger veterans. They tweet, text, facetime and who knows what is next. extended winter. Almost everything came to a standstill. Then the cancellations started; no District, State or National Conventions.

One thing that did not stop was the need for assistance from veterans and military members and their families. In the last newsletter I pointed out the donations made by "Sports Clips" (Help a Hero Scholarship) and "Burger King" (Un Met Needs) so now I will ask you to support these two organizations if you can. As to the needs I mentioned. Just within the past four months Un Met Needs has given out 110 grants totaling \$126,372.14.

Bonds

POSTS THAT DO NOT HAVE BONDS THAT CONFORM WITH SECTION 703 OF THE NATIONAL BY LAWS WILL FAIL THEIR INSPECTION 2020-2021. THIS IS SPECIFIED IN SEC 218, 418 AND 518 OF THE NATIONAL BY-LAWS. PLEASE DO NOT BE ONE OF THOSE POSTS.

Sec. 703 - Bonds.

Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post, as the case may be, to which each officer is accountable.

The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit.

From our National Quartermaster General

Department Adjutants & Quartermasters:

I have recently received several inquiries regarding the subject of bonding. Specifically, Quartermasters are asking if insurance is an acceptable alternative to the requirement that accountable officers be bonded. The information below seeks to clarify this requirement and the difference between bonds and insurance.

VFW By-Laws Section 703 Bonds states:

Each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council, or Post, as the case may be, to which each officer is accountable.

The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit.

Sections 218, 418, and 518 of the Manual of Procedures require bonding of the Quartermasters at each level.

The purpose of bonding is to protect the VFW against actions of the Quartermaster, or other officer being bonded.

There is a difference between bonds and insurance.

A surety bond is an agreement under which one party (the surety company) guarantees to another party (VFW) the performance of an obligation by a third party (the accountable officer). Surety bonds do not have a deductible and do not require a conviction of the officer in order to be paid for the loss. Surety bonds serve to protect the obliged party (VFW) against losses that result from the failure of the principal (accountable officer) to meet their obligation.

Insurance is an agreement under which one party (the insurance company) guarantees protection to another party (VFW) due to dishonesty, forgery, computer fraud, theft, etc. Crime or employee dishonesty insurance policies may be subject to a deductible and may require a conviction of the officer, which can take time, before payment will be made.

So, any policy that provides insurance against theft where there is a deductible and a conviction is required is not considered a bond. A bond is taken out by a party (post) to cover a specific person (post officer) who promises to act in a certain way. There is never a deductible, and no conviction is required. An insurance policy will generally apply to all officers, volunteers and employees who have access to Post funds. Posts need to look at the terms of the contract to make sure they are getting are a bond and not an insurance policy. In many cases, a post may need both an insurance policy for the post and a bond for the individual handling funds.



Apply for **Burial in a VA National Cemetery and for Memorial Products**

This guide will help you apply for burial in a VA national cemetery, a Government-furnished headstone, marker, or medallion for burial in a private cemetery, a Presidential Memorial Certificate and a burial flag for a loved one.

Apply for VA Burial and Memorial Products:

PREPARATION

- Decide whether burial will be in a VA national cemetery, state or tribal Veterans' cemetery or a private cemetery and desired memorial products
- □ For burial in a VA national cemetery, a private cemetery (for a headstone, marker, or medallion) or for a Presidential Memorial Certificate, collect the following information and submit it with your application, if available:
 - Discharge document(s) (DD214 Member-4 or equivalent)
 - Orders, if activated by Executive Federal Order from the National Guard or Reserves
 - → Pre-need determination approval letter (if previously completed)

- □ **Apply** for burial in a VA national cemetery by:

I WANT TO BE BURIED IN A STATE OR TRIBAL VETERANS' CEMETERY

State and tribal Veterans' cemeteries may have different requirements to apply for burial. Please contact the cemetery for a burial eligibility determination.

WHAT IS A PRESIDENTIAL MEMORIAL CERTIFICATE?

A Presidential Memorial Certificate is an engraved paper certificate signed by the current president.

Voice of Democracy Speech



In one of the most iconic paintings by an American artist, two young children, a boy and a girl, sleep peacefully. Next to their bed, the floor is scattered with toys. Shadowy half-light from the open door illuminates the room and we see their parents standing vigil over them as they sleep. Their mother leans down. She tenderly pulls the covers more snugly over her children, as if to guard them

from the tragedy reported in the folded newspaper that her husband holds. A bombing has occurred. There is evil in the world. One might expect to see an anxious countenance, yet we see the father smile lovingly on his children. Both parents clearly understand the horror of that day's news, but these Americans have decided not to let fear settle in their home. One day years ago, my father hung a print of this painting, Norman Rockwell's *Freedom from Fear*, next to the front door of my home. Through this door I and my family go out into a world which sometimes produces headlines even more shocking than the "BOMBING HORROR" immortalized by Rockwell. Yet, we pass through our door without fear, not because we choose to pretend evil doesn't exist in our world, but because like the Americans depicted by Rockwell, we also choose not to let fear settle in our midst.

Freedom from Fear is one of four paintings Rockwell created following President Franklin Roosevelt's 1941 State of the Union address, in which he said, "In the future days, which we seek to make secure, we look forward to a world founded upon four essential human freedoms. The first is freedom of speech and expression–everywhere in the world. The second is freedom of every person to worship God in his own way–everywhere in the world. The third is freedom from want ... -everywhere in the world. The fourth is freedom from fear ... That is no vision of a distant millennium. It is a definite basis for a kind of world attainable in our own time and generation." Since then, Americans of all walks of life have answered President Roosevelt's call, giving their time, talent, and even their very lives, to ensure these freedoms are enjoyed at home and abroad. Though all of these freedoms are essential, the Freedom from Fear enables us to live the other three.

There are many whose heroism and dedication to upholding the Four Freedoms is apparent to all. Their choice to act free of fear has allowed them to live heroically in seemingly hopeless situations. The policemen, firefighters and civilians on September 11, 2001, who died saving others, ensured that every American heart today remains free from the cloud of fear caused by the terrorist attack that day. In May this year, a shooting in a Colorado high school left one student who charged to the rescue dead, another wounded. These two boys, along with the teachers and responders that day, are heroes, standing up for what is right and halting those who would threaten our freedom in their tracks.

However, not only do Americans heroically pursue these freedoms at home, but we go abroad, and we share them with the people of the world. Since 2001, 6,828 American servicemembers have sacrificed their lives to bring these freedoms to the people of the Middle East. On August 21, 2015, Spencer Stone and two of his friends, all members of the U.S. Air Force on leave, hazarded their own lives to save fellow passengers whose lives

were threatened by a terrorist with an automatic rifle on board a train bound for Paris from Amsterdam. These men had dedicated their lives to defending freedom, and they proved their commitment on that train on that day.

Civilians also make great sacrifices for the cause of human freedom. Members of the Carter Center ensure that people in the developing world can live in freedom from the fear of disease. This group, based in the U.S., works tirelessly to eradicate diseases affecting millions in over 80 countries. Through their efforts, the Guinea Worm disease was completely eliminated in Nigeria in 2009.

In 2017, a group of young American engineers, in an organization called Bridges to Prosperity, partnered with a local Haiti community to

build a bridge over the river near their village. The river had a strong current, and many people in the community had lost their lives just trying to cross it. The men and women in Bridges to Prosperity sacrifice careers with big, well-paying companies to be a part of a group that ensures that all people have the ability to live in safety, free from fear.

Like the father and mother in Rockwell's Freedom from Fear, Americans go out into the world not with trepidation, but with emboldened hope that catches the world on fire. We may not always agree on how this blaze should be set, but we do agree that every human deserves a life lived free from fear, free from want, free to speak or write, and free to worship. I am an American. Americans are what makes America great.

Director's Message to Veterans

I want to take a moment to update you on what VA New York Harbor Healthcare System (NYHHS) is doing to support our local community in the fight against COVID-19, while also maintaining our exceptionally high level of care for our Veteran patients.

Helping Veterans is our first mission. From mid-March through June 3rd, NYHHS admitted 402 Veterans to our Brooklyn and New York Campuses for treatment of COVID-19. In times of national crisis, such as the current pandemic, VA provides services to the nation based on requests from states. This is known as **VA's Fourth Mission**. At the request of the State of New York NYHHS provided 50 total beds – 35 acute care and 15 Intensive Care Unit beds – for humanitarian cases. By making these beds available, we saved lives and provided desperately needed relief for city and private hospitals in our community. From March 28th through June 3rd NYHHS treated 111 civilians as inpatients.

In early May, our medical centers in Brooklyn and Manhattan accepted the remaining six non-Veteran, humanitarian patients from the **Javits Center Field Hospital**, helping them close out their mission.


We also accepted the remaining 11 non-Veteran humanitarian patients who were being treated by medical providers on the **USNS Comfort**. Transferring those patients to our medical centers in Manhattan and Brooklyn allowed the Comfort to complete its mission and return home to Virginia.

I want to be very clear that opening our doors to humanitarian, non-Veteran patients in no way impacted Veteran care during the pandemic; every Veteran requiring inpatient or emergency care received the same high-quality service our patients have come to expect from VA NYHHS.

Moving forward together, we will continue to provide exceptional care to our Veterans.

What You Need to Know

- New York City is on track to enter phase two of the state's regional phased reopening plan; Long Island and Mid-Hudson Valley are on track to enter phase three; the Capital Region, Western New York, Central New York, Finger Lakes, Mohawk Valley, North Country, and Southern Tier are in phase three.
- New York City has been cleared by global public health experts to begin phase two of reopening Monday.
- Governor Cuomo signs an Executive order stating that businesses violating the reopening guidelines could result in immediate loss of their liquor license and a shut down order; the area immediately outside their locations are also the responsibility of the business.
- Guidance for colleges and universities to allow some in person instruction and on-campus housing for the fall is coming soon.
- Hospitals and group homes will be allowed to accept visitors at their discretion, while following state guidelines including time-limited visits and requiring visitors to wear PPE and be subject to symptom and temperature checks.
- Governor Cuomo announced the implementation of a new early warning dashboard to monitor and review how the virus is being contained on an ongoing basis.
- The \$100M New York Forward Loan Fund will provide loans to small businesses, focusing on minority and women owned small businesses, that did not receive federal COVID-19 assistance.
- The New York State sales tax filing deadline has been extended to June 22, 2020.
- Governor Cuomo issued executive orders 202.17 and 202.18 requiring all people in New York to wear masks or face coverings in public, including when taking public or private transportation or riding in forhire vehicles.
- New Yorkers without health insurance can apply through NY State of Health through July 15, 2020; must apply within 60 days of losing coverage.
- Health care workers can text NYFRONTLINE to 741-741 to access 24/7 emotional support services.
- New Yorkers can call the COVID-19 Emotional Support Hotline at 1-844-863-9314 for mental health counseling.
- Testing is free for all eligible New Yorkers as ordered by a health care provider.
- Your local health department is your community contact for COVID-19 concerns.
