990's, make sure whoever is responsible for filing it, does so on time. If you go 3 years without filing a 990, you're not for profit status is **automatically revoked**. The commanders are tasked with the responsibility of ensuring 990's and all official documents are filed in a timely manner.

Where does the Department of New York stand financially? We, as everyone with investments are suffering at this point. With our diverse financial investment program in place, we are not as bad as other investors. A full report will be provided at the fall conference.

At a recent Department Adjutants and Quartermaster Association meeting we are finding the issues we are facing in the Department of New York are not unique. Most other departments are seeing the same failures of filing reports, signatures missing and numbers are not adding up. The members of Posts, County Councils, Districts and Departments need to participate in the organization to ensure the rules are equally applied and enforced. It is time for Trustees to begin the 4th (Fiscal year) quarters trustee's report. This report to the members of the Posts, etc. will provide a peek at the complete financial picture.

There will be some Life members purged from the rolls this year. So, beware when the life members are again counted for in the memstats report. Look over the members and if you find one or more members in your Posts were eliminated and remain alive, contact National Headquarters, membership for reinstatement.

One final note, if you feel there is or are misleading financial activities in your Post, speak

-up at a meeting. Have the issues addressed. Motions may be made to require the commander to be accountable to the members on all matters within a post.

Some People May Face Reduced Social Security Benefits

Social Security benefits are on the rise. The 2022 cost-of-living hike was nearly 6%, and there's no sign inflation is slowing down.

In other words, Social Security may now be making up a larger part of your [retirement income strategy](#) or playing a bigger role in your retirement income plan.

Ideally, guaranteed income streams like Social Security, [military retirement](#), pensions and income annuities can cover your core expenses in retirement. So this type of increase is good news, especially if inflation fades. In the end, it's all about relative purchasing power.

What you don't want is a not-so-good surprise. There are two Social Security rules that might provide just that: the Windfall Elimination Provision and Government Pension Offset.

These rules could come into play if you or your [spouse](#) receive pensions from work where they did not pay Social Security taxes.

Let's [look before you leap](#) and examine these two rules a little closer.

Windfall Elimination Provision (WEP). This rule affects the Social Security retirement and disability benefits of folks who receive pensions from work for which they didn't pay Social Security taxes. Federal workers under the old Civil Service Retirement System and workers in some public-

school systems are prime examples. In these cases, the Social Security Administration could modify your benefit calculation, resulting in a smaller Social Security payout.

You can read the details on the Social Security website or by checking out [Social Security Publication 05-10045](#). On the positive side, if you have 30 years of what are called substantial earnings, the rule won't affect your Social Security. If you've got at least 20, the impact on Social Security is lessened.

Government Pension Offset (GPO). This rule also targets recipients of non-covered pensions, but it affects benefits they might receive based on their spouse's earnings record. It reduces or eliminates the benefits received as a spouse, widow or widower -- cutting them by two-thirds of the amount of the non-covered pension. For example, a \$1,000 pension from a job where Social Security taxes were not paid would reduce any Social Security benefits received as a spouse by \$667. This could be a game changer if your survivor income plan relies heavily on Social Security benefits that might not be available. It is detailed in [Social Security Publication 05-10007](#).

In the end, you might not be able to avoid WEP or GPO, but you should understand how you or your spouse might be affected and plan accordingly. Visit the Social Security website or search the referenced publications for more information.

Survivor Benefits and Planning

One of the things I have ran across as a service officer is the assumption that the veteran's spouse or family will automatically get VA benefits. One of the misconceptions is the surviving spouse will get 50% of the veteran's VA disability compensation if the veteran passes

away. It is true the spouse and possibly family members may be eligible for VA benefits, it is not automatic. The following is to assist veterans and their families to prepare.

Survivors' Dependency and Indemnity Compensation (DIC) is a benefit for the surviving spouse of a veteran who passed away from a service-connected condition. Generally, if one of the rated conditions aligns with the cause of death (to include secondary or tertiary causes) the benefit will be granted. If the veteran's cause of death hasn't been rated by the VA but can be tied to their service e.g., ischemic heart disease for a Vietnam vet which is a presumptive condition for Agent orange exposure it will be granted albeit with more documentation. The financial compensation for DIC is not based on the veteran's percentage. A veteran rated at 10% collecting \$152 a month or one rated at 100% getting \$3517 monthly doesn't change the rate for the surviving spouse (currently \$1437 per month).

There is also Survivors Pension which is a tax-free benefit payable by the Department of Veterans Affairs (VA) to a low-income, unremarried surviving spouse and unmarried dependent child(ren) of a deceased wartime Veteran. To be eligible for this benefit, the claimant must be the eligible surviving spouse and/or child(ren) of a deceased wartime Veteran, who meets specific income and net worth requirements. Children may be eligible if they are any of the following: Under the age of 18. Between the ages of 18 and 23 and enrolled in a VA-approved educational/training institution. Permanently incapable of self-support prior to the age of 18.

As many of you are aware, some claims are taking a very long time to be finalized. Three new presumptive conditions for Agent Orange exposure were added in January 2021. We received several new claims and previously denied ones were reopened by the VA. This created another backlog, and many have been awaiting a final decision for over a year. What happens if the veteran passes away prior to the decision? There is a thing called substitution. Substitution allows a person eligible for accrued benefits to substitute a deceased beneficiary on a pending claim or appeal. The substitute claimant may submit evidence in support of the pending claim or appeal for potential accrued benefits. The

spouse or eligible beneficiary will keep the claim open for the VA to eventually adjudicate and receive any payments that would have been due the veteran (if filed within one year of the veteran's death). If you have a condition that is service connected or a presumptive condition, file a claim. If you are concerned it won't get finalized in time due to health or age it may still benefit your family.

A couple of recommendations I have that will assist in your planning and help ease your family through a difficult time. Firstly, make sure they know where your DD 214 is. I can't count how many times I have been asked "how do I get my husband's or father's DD 214?". If you don't have it, it probably won't be on file at your VFW post but may be on file your county or town clerk's office if you went there after separation or bought a house and got some form of break on your taxes. If not, it can take a long time to have one reissued by the National Records Center.

Secondly, if you have worked with a service officer from one of the veterans' organizations, let your family know. We can assist with getting any benefits that are due. We represent surviving spouses just as we did the veteran in filing claims and dealing with the VA. If we represented the veteran, we would have access to their file, and this will ease the process for DIC etc.

This is not an in-depth guide but an overview. If you or your family need assistance with any benefits or understanding the things that may be available, please contact us, the service officers are happy to help.

Greetings!

It is impossible to believe but we are again beginning a new VFW year. I have very little to report since my last article to you. National has been very involved in closing out the year and coordinating with the National Membership Department to get all those well-deserved awards out to the Posts, Districts and Departments who worked so hard to increase VFW membership this past year.

I would like to offer my congratulations to all the newly elected officers at the Post, District and Department level. Take your position and responsibilities seriously. Review the requirements of your office and take action accordingly. Attend Officer Training (OTI) at your earliest opportunity. Things change. You will learn something at every training event. Make sure you know what has to be done. It is your guidance, informed knowledge and leadership that will make your Post, District and our Department successful in all endeavors.

I am preparing to head to the National Convention on July 15th which will be held in Kansas City again this year. The main focus of the National Council will be to pass the National budget for the 2022-23 year. I am not only heading to the Convention as your National Council member but have been assigned to the Budget and Finance Committee for this Convention.

My last communication from National which was June 17th indicated that there were 939 posts who have not filed election reports for 2022-23 with 273 still outstanding as of July 8th. The Department of NY experienced similar failures to report again this year again with some eight posts still outstanding as of this writing. Election Report filing still seems to be a recurrent problem which needs to be resolved and addressed. Posts need to do much better in meeting the deadline for report filing. Failure to do so puts a Post in jeopardy of losing their charter. It Hampers the Department from compiling the information required for an annual directory and requires many manhours of work to notify all members in each post failing to submit a report to attend special meetings to address the issue and elect officers. We all know the requirement – nominate in March, elect in April. Reports should be submitted immediately following the elections. There should be no excuse.

The Veterans Administration Office of Inspector General (OIG) has issued a fraud alert regarding VA being billed for care veterans did not receive. This alert advises veterans and their representatives to help detect health care fraud by carefully reviewing benefit explanations and bills they receive from the VA. If you see potential evidence of fraud or have concerns about patient care, please contact the VA OIG office at va.gov/oig/hotline or 1-800-488-8244.

On the Legislative front the VFW currently supports 171 bills; and opposes one bill pending before the 177th Congress.

National currently has 45 posts under suspension and are engaged in 16 Article IX disciplinary actions and five member eligibility challenges.

For those attending the National Convention July 16-21, be sure to download the updated VFW Events App to ensure you have everything convention related at your fingertips. The app is available for download at both the Apple App Store and the Google Play Store by searching "VFW Events." Have a safe trip!

Hello Comrades,

As the new District 5 Commander I am excited to take the position, to assist and inspire as many veterans as I can. I want to provide you a little information and background about who I am. Having joined the military in 1991, I spent 27 years in the military including 15 years in the Army and 12 years in the Airforce. During my service I held numerous jobs to include Field Artillery, Water Purification, Combat Engineer, and duty as a Drill Instructor while serving in the Army and as an Electrician while in the Airforce. I been to 10 different countries and serve on 6 deployments; In other words, I have seen my share of things and done any different jobs, which will be an asset in assisting the District. Towards the end of my military career, while I was seeking help for myself, I found that many other veterans and transitioning service members were blocked by various problems just as I was.

LINDENHURST VFW POST 7279

A fire in September 2019 did extensive damage to the post. The fire ravaged the two story building and smoke and water damage ruined the rest of the building. The post lost everything. They used the insurance money to rebuild and bring the hall up to code but the contractor did not finish the job.

The post relies on the revenue from fundraising events and hall rentals and without that income the post's savings have diminished. Volunteers from various trade unions have offered their time but the skyrocketing costs of materials have delayed the rebuilding process.

The town of Babylon received \$27.77 million in federal American Rescue Plan Act funds and distributed the money to the town's three villages based on their size and needs. For Lindenhurst, the officials felt that \$380,000 should be used for the VFW building.

"When the fire happened, it not only eliminated a meeting place for the VFW but it eliminated a place for the community to have evented" said town Councilman DuWayne Gregory.

The work to be done includes ceiling, flooring and drywall installation as well as painting, Gregory said.

The town performed a site inspection in mid-June and will hire a contractor with the goal of having the building completed by Veterans Day November 11, 2022.

The village is planning a fundraiser for the post on September 4, 2022 called "Vetstock" featuring a day of bands playing at the gazebo.
