As you know, effective July 1, 2023, National increased the cost of the traditional "Legacy" Buddy Poppy. National has represented that the quality of the "Legacy" Poppy has significantly improved, and all Buddy Poppy orders will be shipped within ten days of receipt of the order!

and then department headquarters for a correct way to proceed. You may need to contact the local police and file a complaint.

Let's chat about the Post trustees. Your trustees are probably the most important officers in your Post. The department OTI's are and have provided training for post trustees. At the next regular meeting or at a specially called meeting, the trustees report their findings to the body of the Post. If there are any issues with the audit, those issues need to be addressed at the meeting and resolved. After signatures, the post Commander forwards a copy of the report to department headquarters.

If the Post has a canteen, the quartermaster is responsible for those funds and the trustees have the responsibility to audit those records as well.

What are the important sides of the investments are the dividends we are receiving, and they are doing well.

Comrades,

The Justice Department and the Department of the Navy (DON) today announced the finalization and publication of a voluntary process, called the "Elective Option," to help veterans and others more quickly resolve qualifying claims under the Camp Lejeune Justice Act (CLJA) of 2022. This option supplements other processes currently available under the CLJA, which remain in place.



The CLJA is a provision of the Honoring our Promise to Address Comprehensive Toxics Act, which was signed into law on Aug. 10, 2022. The CLJA allows those who file claims and lawsuits to potentially recover for injuries caused by exposure to contaminated water at the Marine Corps Base Camp Lejeune from mid-1953 through 1987.

Established jointly by the Justice Department and DON, the new Elective Option provides a framework for the DON to resolve certain CLJA claims quickly, equitably and transparently. In order to be eligible for the Elective Option, a claimant must first submit an administrative claim to the DON. To date, more than 93,000 CLJA claims have been filed with the DON.

The Elective Option allows the DON to focus its review on a few key aspects of a CLJA claim, such as the type of injury alleged and the amount of time a claimant worked or resided at Camp Lejeune. Narrowing the scope of the review

enables faster validation and, ultimately, extension of settlement offers. The Elective Option provides similar settlement offers to claimants with similar exposures and injuries with similar evidence of causation.

"The Elective Option is a critical step in bringing relief to qualifying claimants impacted by the contaminated water at Camp Lejeune, who will now have an avenue for receiving quick and early resolution of claims under the Camp Lejeune Justice Act," said Associate Attorney General Vanita Gupta. "We are grateful for the continued partnership of the Department of the Navy and federal agencies in developing and administering this framework."

"The Elective Option presented today should be of great interest to eligible Americans who seek a streamlined process to resolve their claims," said Under Secretary of the Navy Erik Raven. "We recognize this takes a whole-ofgovernment response, and along with DOD and DOJ, we are linked with Veterans Affairs and other federal agencies to support a fair and streamlined process. We are committed to ensuring that every valid Camp Lejeune claim is resolved fairly and as expeditiously as possible." Within the framework, the DON can make settlement offers to qualifying claimants with diseases that the Agency for Toxic Substances and Disease Registry (ATSDR) has determined are linked to the chemicals found in the water at Camp Leieune. Award amounts are tiered, largely based on the ATSDR's classification of the evidence strenath of the linkina contamination with a particular disease and the amount of time the individual spent at Camp Lejeune.

Tier 1 Diagnoses: Claimants with diseases for which the ATSDR has substantiated evidence of causation – kidney cancer, liver cancer, non-Hodgkin's lymphoma, leukemia and bladder cancer – would receive settlement offers of \$450,000, \$300,000 or \$150,000, depending on whether the claimant was exposed to Camp Lejeune water for over five years, between one and five years or between 30 and 364 days, respectively.

Tier 2 Diagnoses: Claimants with diseases to which the ATSDR has linked possible evidence of causation – multiple myeloma, Parkinson's disease, kidney disease (end stage renal disease), systemic sclerosis/systemic scleroderma – would receive settlement offers of \$400,000, \$250,000, or \$100,000, depending on

whether the claimant was exposed to Camp Lejeune water for over five years, between one and five years or between 30 and 364 days, respectively. Claims involving death would receive an additional \$100,000.



The Elective Option supplements other mechanisms for resolving claims currently available through the normal administrative claims or litigation processes. Claimants not eligible for the Elective Option may await finalization of their administrative claim or pursue litigation and engage in any broader settlement discussions occurring through court proceedings in the Eastern District of North Carolina. The Justice Department will screen already-filed lawsuits and will extend settlement offers in qualifying cases that are similar to awards under the Elective Option.

Those interested in learning more about the Elective Option should visit <a href="https://www.navy.mil/clja">www.navy.mil/clja</a>. Individuals who think they qualify for relief under the CLJA can follow the instructions available on that site to submit a claim and provide requisite supporting documentation. There is no requirement to retain a lawyer to file a claim or subsequently pursue an expedited resolution. Claims that have already been filed with DON do not need to be refiled.

Payments under the Elective Option are not offset by the Department of Veterans Affairs (VA) disability benefits or VA medical care, and they do not impact ongoing treatment and support provided by the VA.

side of the National organization. Every effort was made to streamline expenses and review investment strategies to maximize income. At the C of A following the budget workshop, the 2023-24 National budget was passed by the C of A.

In addition to the budget workshop, other important departments at National provided some enlightening and interesting information during their presentations. For those who may not know, 800,000 claims have been received by the VA under the new Pact Act legislation with 70% of those claims processed by Certified Claims Officers. The average claims received by the VA are about one million per year.

The VFW is still pursuing the awarding of the Foreign Expeditionary Medal for those troops on the Eastern Flank of NATO. JCS gave reasons why it did not meet the criteria for the awarding of the medal when the proposal was presented but the VFW is still pursuing the goal of eligibility for those troops on the Eastern flank of NATO. I am sure there will be more to follow.



For those who may not have read about the change in of the latest one editions of the VFW magazine, magazine will begin going digital and the paper edition of the magazine eventually being phased out with regard to mass distribution to all members. For those

who desire to continue receiving a paper copy of the magazine, you **MUST OPT IN** to continue receiving it. As the Department Judge Advocate, it is my duty to advise the Department Commander and the Department Council of Administration based on the National Bylaws and Manual of Procedure. Aug. 10, 2022. VA has processed more than 551,000 of these claims, granting 77.9% of them and awarding more than \$2.2 billion in earned benefits to Veterans and survivors. The Service Officer is the one supporting Veterans and their families to address military related toxic exposure.

# Pat Iuliucci POW/MIA CHAIR



Comrades,

September 15<sup>th</sup> was National POW-MIA Remembrance Day. On this day, the Federal Government flies the American flag at half-staff, from sunrise to sunset, on all government buildings. I hope that all of our comrades have taken a moment of silence to show our deepest sympathy for those who have paid the ultimate sacrifice. Today as of September 25, 2023, there are still more than 81,000 American service members whose remains have not been recovered. WWII - 72,200; Korea - 7,497; Vietnam - 1,579; the Cold War - 126; the Gulf War -5; El Dorado Canyon - 1, as long as there is one service member still unaccounted for, the mission of DPAA will continue to search and recover the remains of our missing and be returned home for a proper military burial. Every day of the year, we must continue to promote and bring awareness to the importance of the POW/MIA issues in communities and with our Legislators by setting up



the Missing Man Table, not only at our post but with the permission of our local businesses to set one up at their establishment.

Recently Accounted For are being returned home for a Military Funeral and Burial are three servicemembers from WWII. PVT. Wing O. Hom, missing in action during WWII, was accounted for April 6, 2023. In February 1944, Hom was assigned to Company B, 7<sup>th</sup> Infantry Regiment, 3<sup>rd</sup> Infantry Division. On February 2<sup>nd</sup> Hom went missing in action

when his unit engaged in defensive fighting against German Forces near the town of Cisterna di Latina, Italy. His body was not recovered and the Germans never reported him a prisoner of war. The War Department issued a finding of death on February 3, 1945. Pvt. Hom will be buried in Evergreen Cemetery, Brooklyn New York on October 11, 2023, at 1100 hrs.

Army Sgt. Bernard J. Sweeney Jr, 22, of Waterbury Connecticut, killed during WWII, was accounted for June 14, 2021. In December 1944, Sweeney was assigned to Company I, 330<sup>th</sup> Infantry regiment, 83 Infantry Division. His unit was engaged in a battle with German forces near Strass, Germany, in the Hurtgen area. Between 1946 and 1950 searches took place but were unable to recover or identify Sweeney's remains. He was declared non-recoverable in November 1951. Sweeney will be buried with Military Honors on October 10, 2023, at Calverton National Cemetery in Riverhead, NY.

Army Air Forces 2<sup>nd</sup> Lt. Albert W. Stahl was assigned to the 329<sup>th</sup> Bombardment Squadron (Heavy), 93<sup>rd</sup> Bombardment Group (Heavy), 9<sup>th</sup> Air Force. On August 1, 1943, the B-24 Liberator bomber in which Stahl was the navigator, was hit by enemy anti-aircraft fire and crash during Operation TIDAL WAVE, the largest bombing mission against the oil fields and refineries at Ploiesti, north of Bucharest, Romania. His remains were not identified following the war. In 2017, DPAA began exhuming unknows believed to be associated with unaccounted- for airmen from Operation TIDAL These remains were sent to the DPAA Laboratory at Offutt Air Force Base, Nebraska, for examination and identification. Stahl will be buried in Kenmore, New York in the Spring of 2024. I will keep you posted on burial information as it becomes available. 
