These entries are essential to ensure that the National Organization has accurate statistical information on our Department's Program activity. It is the primary responsibility of the Adjutant to make entries on the Dashboard, but authority is granted to Commander, Sr. Vice Commander, Commander, and Quartermaster to make the entry as well. Please review the Commander-in-Chief's membership Program for further requirements to meet the All-American Membership Program for the 2025-2026 year. The All-American Membership Program is designed to recognize exceptional leadership and accomplishments membership growth and VFW core Programs.

Please be aware that Department Headquarters is having difficulties sending out emails to members that have old Roadrunner (rr.com) accounts. As of October 2023, sending or receiving emails from these addresses has been discontinued for most users. Existing accounts may still

downloading the most recent list of moneys due Posts in the Department, I be mailing this list to the post Commanders and Quartermasters for your action. This will be the final time I have searched and sent the lists out. Most of the post which I have contacted in the past have not applied for their funds. If you do not want to apply for these unclaimed funds, please send me a letter signed and notarized for the Department to acquire the funds. I am not going to do this and then return the funds to your Post.

You may need a copy of the most recent election report to prove the current Quartermaster is the authorized officer to receive these Unfortunately, there are Posts which have lost their charters and these funds are now being recovered by the department. Some posts have 2 or 3 unclaimed funds awaiting their applications. One defunct post has 5 accounts sitting for recovery.

Each person in the Post, District and the Department which handles funds for the respective entity, needs to be bonded. The bond must be sufficient to cover the annual average of the amount of assets the individual will have access to or controls. Who needs to be covered. Bar Stewards, Quartermaster, Assistant Quartermaster (if there is one). Anyone else which comes in contact with the funds of the organization, this includes Bell Jar raffles, bar funds, and investments.

The list of unpaid annual members in our post 15033 (at-large) is over 10,000 members. It is a huge task to be able to sort these names into District lots. The lists are almost complete, and I will be sending them the Department Membership Officers Chairmen, District and associate membership co-chairman for distribution and or a district membership drive. These unpaid members can be a boon for your Post. Set up a day and a phone committee to reinstate these members into your post.

Defunct Posts seem to be growing in number and the assets of these posts become the property of the department. The issue is recovering the funds and assets. PLEASE work on membership to retain the funds within your post.

It is recommended that officers at all levels obtain a copy of the current 2026 podium edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual, which are available through the VFW Store at National Headquarters or you can download the digital version from the National webpage for free. The 2026 revised edition reflects the amendments adopted by the 126th National Convention.

It is the responsibility of the Commander along with the Senior and Junior Vice Commanders to enforce strict observance of the laws and usage of this organization including Post, District and Department Bylaws along with the Congressional Charter, National Bylaws, Manuel of Procedure and Ritual and all lawful orders from proper authorities. Therefore, it is also recommended that copies of the District and Department Bylaws be obtained also.

To sustain the Veterans of Foreign Wars reputation and assure its continued success, I recommend that all Post and District Commanders read the Department of New York's Code of Ethics, which can be found on the Department's webpage, and either

# **Harold Patchen** STATE INSPECTOR



#### Comrades,

I wasn't sure if I should start with this statement or end with it. NOW, is the time for inspectors to begin their inspections. We don't want to wait too long because we may have to fight the snow and other bad weather. Besides, once they are completed you can relax. Inspections are not to find faults per se but to look for things that could get a post into trouble. I look at it as a way to SAVE POSTS. If we continue to "kick the can down the road", posts will eventually end up turning their charters in. If you are "gigged" by your inspector today and you correct the finding, you may years down the road think "I'm glad now that these things were found by the inspector". Post Commanders and Quartermasters are encouraged to work with the inspector. Have your prior year inspection form, your IRS-990, your most recent quarterly report, officers file, Bond paperwork etc. ready before the inspector arrives. Each post should have a copy of their IRS-990, most recent quarterly report, copy of bond (unless bonded by the Department of N.Y.) AND the new (this year) Post Inspection form ready for the inspector to

take back with him or her. This new form needs to be signed by the post commander AND inspector.

This year all inspectors need to turn in finished inspections first to their respective District Inspector for review. After district review, they'll be forwarded to the Department HQ. for approval. This will allow the posts to get a head start on fixing the necessary items.

Deficiencies that I've seen so far are:

Item 1. Post Bylaws in accordance with section 202 of the National Bylaws.

Item 2. Is the Post Incorporated in accordance with section 708 of the National Bylaws?

use the Departments Code of Ethics or draft one of their own for their offices to sign. The integrity of all our officers is vital to the success of organization.

As a reminder, as we move towards the upcoming elections cycle, I direct everyone's attention to Article VII, Sec. 702 of the VFW National Bylaws, which states, "No Post, County Council, District, Department or the National Organization, or any component part or member thereof, shall participate in any way in a campaign of a candidate for any partisan public office..." This applies to fundraisers, endorsements, and the use of VFW facilities or names in any way that suggests the VFW is supporting a candidate.

The Post building may be rented or used by a political campaign for an event, and this is done the same way as with any other private group (e.g., through a rental agreement, without promotion or endorsement by the Post), this may be permissible, as long as:

- The Post does not advertise, promote, or sponsor the event.
- The event does not use VFW branding or materials.
- The Post does not show favoritism or exclusivity to one candidate or party.
- The Post ensures equal opportunity for other candidates to rent the space (if requested)

The Commander and the Post membership must take great care to avoid giving the impression that the VFW is endorsing the candidate in any way.

Always remember, if you're not sure, ask first.

Item 26: Does the post carry all proper types of insurance. Our Department Adjutant Bob Mitchell and I called National last week to see if or what insurance is needed by posts that don't own a building and meet at churches, other Veterans Clubs etc. We are waiting for a ruling. We apparently aren't the only department with this question.

Many posts are pushing the three-year limit with no IRS-990's filed. Remember they are expensive and time-consuming, so don't forget to get them done. Remember also that by now all posts are expected to have post by laws. I know that some are IN PROCESS, waiting for department and National approval. All bylaws should be reviewed and updated every 5-8 years at the minimum. One post, in reviewing their 20+ year old bylaws, found that to have a legal meeting they needed 20 members. That was updated quickly.

# Gene Ratigliano, **PSC** NATIONAL COUNCIL **MEMBER**



Greetings from your National Council Member!

I just returned from a three-day session in Kansas City where we had a very successful and intensive budget workshop and C of A meeting. Commander Whitmore has appointed me to the National Budget and Finance Committee as well and the National Audit Committee, which I am very appreciative of but requires a little longer stay at these meetings in Kansas City and other conference locations moving forward in the 2025-26 VFW year.

Having a place on the National Budget and Finance Committee enables us to have a say in how the budget is prepared and be involved in the recommendations that concern how our dollars are spent as an organization. A full day workshop entailed reviewing the actual results of the 2023-24 budget year, the current 2024-25 actual revenues and expenses through July 31, 2025, the 2024-25 budget and an in-depth review and analysis of spending to be projected for the 2025-26 VFW Year which was presented to us by Budget Chair Debra Anderson.

The Financial Report included as of July 31, 2025 the General Fund Cash and Investments balances totaling \$123,274.454.00, Council Designated and Donor Restricted Funds of \$50,690.247.00 and Total Unrestricted Cash and Investments \$72,584.207.00. VFW National experienced a 20% decline in equity markets during March and April of this year but the markets have rallied since that pullback. VFW National overall Cash and Investments has increased \$3.8 million since the beginning of the Projections look good for most fiscal vear. departments to come within budget estimates with brighter prospects for the 2025-26 year. proposed budget as it stands right now includes \$102,674,000 in revenue and expenses.

In addition to the financial review of the previous and projected budget and salary reviews and discussions held, a major presentation and discussion centered around the DC Memorial Building renovation project. For those who may not be aware, the VFW owns an historic building in Washington D.C. located in the

clustered area of the Congressional and Senate office building complex located at 200 Maryland Avenue, Northeast. Representatives Chester Bartels, STEAM Collaborative, Mike Clay from New Age Construction and Ashly Lawson, New Edge Construction provided an in-depth analysis of the construction overview to date and findings the National Council would need to contemplate and take action on if it so desired.

Based on the initial approved construction plan, in June, building permit requests were submitted for HVAC replacement and exterior window replacement. In July an exterior window design package was submitted to the Commission of Fine Arts with approval granted in August as well as temporary space being worked on for a move out of the DC building and relocating at the United Methodist Building nearby. Demolition and construction was to begin in October. An initial budget based on a 2023 feasibility study set the cost of renovations at \$8,394,750.00 and Budget based on Building Permit drawings increased to \$9,221,765.00. contractor went into the building and assessed the work based on the drawings, they found that other issues were identified that needed to be addressed driven either by code requirements or end-of-life use of the equipment. The following needs (required work) drove the cost up a little more:

- Chiller Failure and Replacement (940K)
- Exterior Window Replacement (780K)
- Fire Alarm expansion (VAV/FCU/EAV) shutdown (310K)
  - Hazardous Materials Report & Abatement (240K)
  - Design Development/CA (150K)\_
  - Required project changes (+1,420,000)

# **Colin Anderson DIRECTOR VETERAN SERVICES**



Comrades,

As you are probably aware of, the Post (District) Service Officer is no more. At the 126th National Convention, delegates adopted an amendment to the Veterans of Foreign Wars National Bylaws that changes the official title of Post Service Officer and District Service Officer to Benefits Advisor.

The following are from the 2025 Post Benefits Advisor Guide:

What is a Post Benefits Advisor (PBA)?

Post Benefits Advisors are local ambassadors of the VFW who help veterans and their families by providing information and connecting them with important resources.

What is a Post Benefits Advisor (PBA)?

Post Benefits Advisors are local ambassadors of the VFW who help veterans and their families by providing information and connecting them with important resources.

Essentially the Post Benefits Advisor is the subject matter expert on Veteran's benefits and resources in your area. The accredited Department Service Officers will handle Federal benefits. The PBA must know where to direct veterans for assistance with VA benefits (send them to an accredited VSO), VFW benefits, emergency financial help, homeless shelters, local and state benefits e.g. property tax relief and employment resources. It may be as simple as how to get a veteran's discount at Lowes or Home Depot or more complex things such as grants from state agencies, veterans service organizations

The PBA should have a way to reference the available resources in their area. Many are available online. New York State offers many programs for veterans. They are easy to access through the NY Department Veterans' Services of website Most counties have a (www.veterans.ny.gov). veterans' service department who should be familiar with local resources. For those in New York City, the NYC Department of Veterans' Services

This raised the projected project cost to: \$11,691,765.00

As the building was being evaluated for this construction it was determined that other areas should be looked at for possible upgrade and/or replacement which would be the "Wants." This new "Wants" list would require a revised budget. These "Wants" included:


- Wet Fire Suppression (710K)
- Cooling Tower Replacement (765K)
- CH Water Pump Package Upgrade (280K)
- Plumbing/Sanitary Piping Replacement (280K)

This raised the total project change to \$16,196,765.00)

In the final analysis, after much discussion it was determined that once construction began, walls opened up, street tear-up and construction would be a good stewardship opportunity to make these additional upgraded changes. By taking this action the VFW would in the long run be saving a great deal of money as these "want" systems would require replacement at some time in the future. drawings, permits, security, and reopening areas previously worked on would need to be done in addition to the added costs associated because of inflation and increases to the equipment and systems

themselves.

Added to the discussion of including these additional changes was an idea presented that offered an option to open up the rooftop area of the building for upgrade to be used for rental purposes to mitigate the increased added costs to the reconstruction project. Other buildings in the general vicinity of the VFW DC office building rent their rooftop spaces for thousands of dollars and presents a financial benefit to consider. I bring these detailed cost projections to you because it is a very large expenditure of our VFW dollars and as members you need to know how our money is spent and why.



Following the review of the budget, construction related to the DC office building and the retirement plan board Quartermaster General Garduno spoke about the proliferation of Department foundations and their use of the name and marks of the VFW. It has been determined by Quartermaster the

General that Department foundations should not be using the name and marks of the VFW, and something needs to be done to correct this situation and a motion would by made to address the issue.

Additionally, Quartermaster General Garduno brought up the topic of the proliferation of the name of the VFW and marks of the organization not only being used by foundations but also the many Departments, Posts, Councils and Districts using the name, logo and marks of the organization without proper authority and is asking for assistance in keeping this from occurring.

Adjutant General Dan West addressed questions that were presented by Council members for discussion during the workshop. Additionally, he proposed a motion for the VFW to approve a licensing agreement between the VFW and Torch LLC and authorizes the Adjutant General and the Quartermaster General and direct that the licensing revenue be applied according to VFW policy and practices. The motion was seconded and was passed by the Council. Torch is a company that sells a variety of flavored beverages

that contain 10mg of THC and would be marketed to VFW posts across the country that may have a desire

to order through their distributors. Although the VFW is entering into an agreement with Torch, LLC it is not an endorsement of the product.

Our last day was wrapped up with a formal Council of Administration meeting prior to our departure from Kansas City. The following motions were brought before the Council. The following motions came out of Committee and did not require a second:

- Adopt the budget for Fiscal Years 2025-26 - Passed
- Rescind the motion previously approved at the March 25 Council meeting requiring the contractor to provide a payment and performance bond from a security company (required a 2/3 approval of the Council). - Passed
- Approve allocations of \$100,000.000 for Capital expenditure in the Kansas City building Passed
- Approve to adjust the employee salary brackets by 3.3% - Passed
- Approve Carroll Jeff the Retirement Plan Board for a 5-year term beginning in March 2026 – Passed
- Approved to deem that West Virginia has terminated its retirement plan since they ceased to have any remaining participants or eligible employees - Passed

The following motions were presented that were discussed the previous day and put on the floor and would require a 2<sup>nd</sup> following the motion:

- To approve an increase of \$ 10.6 million for a capped total of \$19 million to the DC Memorial Building Project. The motion was seconded and passed.
- Move that the Council direct all units who have created foundations or charities that use the VFW's name or marks in any form shall disclose their existence within 90 days by providing the Quartermaster General with their EIN, most recent 990 filing, latest set of bylaws and Articles of Incorporation to assist the creation of a mechanism for compliance and oversight. The motion was seconded. Motion Passed.





VA has processed more than 551,000 of these claims, granting 77.9% of them and awarding more than \$2.2 billion in earned benefits to Veterans and survivors. The Service Officer is the one supporting Veterans and their families to address military related toxic exposure.

#### Game changer for POW's, How Monopoly got personnel out of Germany During WW II

The game of Monopoly is complex and in its appeal to one's inner tycoon, all American.

Its rise in popularity began when the Salem Massachusetts firm Parker Brothers bought the rights to it. Before long as Philip E. Orbanes writes in his new bool "Monopoly X", the game had appeared in movies, inspired a song and graced a range of merchandise, including greeting cards. By the late 1930's, its impact on culture was comparable to that of the "Star Wars" movie trilogy 40 years later. The craze went international, and for the British market it was decided the street names of Atlantic City had to go.

Orbanes includes an amusing vignette in which Victor Watson, head of the Leads printing company that was tapped to manufacture Monopoly in Britian, embarked with his secretary on a renaming bridge, crisscrossing London on the Underground's Circle Line to find replacements for Boardwalk, Park Place, etc. "They selected streets ranging from shabby Old Kent Rod to elegant Mayfair" he writes.

A special version of the game, called Monopoly X, seemed to have debuted in 1941. It was a prisoner of war edition with a false bottom that could hide rations, medicines and escape tools such as cutters, saw blades and maps printed on silk for easy folding into concealable size. Delivered by the Red Cross, which to preserve its neutrality was kept in the dark, the games generally arrived in threes, only one of which - marked by a tiny sticker on the box - was doctored. Thus, if a guard happened to open a box and checked its contents, the contraband still had a good chance of reaching prisoners undetected. In "Monopoly X" Orbanes explores how this ingenious rendition of a beloved pastime helped numerous Allied prisoners of war get out of jail and Nazi-held territory under the protection of Allied forces through a network of secret routes and safe houses. Most of the prisoners held were British, French, Dutch and Finnish. The book's most appealing hero is Airey

This is only for the first quarters; we are moving in the right direction but are behind last year's total. I know we could do much better. On the reporting of community service, you must remember that the VFW year goes from 1 July - 30 June, to have your reports count it must show that the activity happened within the 1 July - 30 June time frame. Also, the description on the reports must have more than one word explanation, one word is not a description. The best way to ensure your reports are in the correct time frame is to do the report in the same month you did the activity.

So, with that said, let's continue getting in our community service reports in.

Neave, an Oxford grad who pulled off a thrilling Monopoly X aided escape from Germany's Colditz Caste, the dumping ground for recaptured escapees from other prisons. He also fingered Cole as a serial deceiver and overcame resistance to that accusation from the bullheaded chief of Britian's intelligence agency MI-6, into whose good graces the brazen Cole had insinuated himself. Making periodic appearances in the story is a decoded message charging that an unnamed traitor lurked in the place you would expect to find him: President Franklin D. Roosevelt's White House. By the process of elimination, Orbanes pins the rap on FDR's brilliant and versatile advisor Harry Hopkins. It's a contested issue - other historians clear Hopkins of treason but charge him with naivete towards the Soviet Union, then an American ally - Orbanes makes a good case for his verdict. Also worth noting are two facts about Monopoly's later life: The X model was deemed so touchy a subject that its existence was kept secret until 1985, and standard Monopoly did not become "officially available" in Russia until 1991.

Still unaccounted for: WWII -73,515; Korea- 7,841; Vietnam- 1,626; Cold War- 136; Gulf War- 6.

# **POST 7227 DIONNE-RUMBLE POST**

CARTHAGE - A story that began in 1944 in France came full circle July 18 in Carthage

First Lt. Paul E. Chaufty, of the Army Air Forces, pilot of a P-47 Thunderbolt, was shot down following a raid over France just after D-Day. Nearby villagers saw the plane being hit and went to aid the pilot.

Marie-Therese Bastien was 14 years old in 1944, when she saw Chaufty's plane go down and the pilot parachute out.

Lt. Chaufty's parachute failed to open and he fell to his death. Bastien's father recovered the lieutenant's body before the Germans could find it.

In August 1948, the remains of Lt. Chaufty were returned to the United States. He was interred in Fairview Cemetery in September 1948. According to a Carthage Republican Tribune account, full military rites were conducted by members of the American Legion Bassett-Baxter Post 789.

To the French villagers, Lt. Chaufty embodied the American liberation of France. Community members formed the Paul Chaufty Association and set up a website that details Lt. Chaufty's military career, has interviews and details about a ceremony held last year to honor the fallen American aviator. The website points out that Lt. Chaufty died "sacrificing his life for our freedom."

"Its engagement took place during American aviation support for the troops of the 2nd Leclerc DB and the 3rd US DB, who were advancing towards Argentan and working to strangle the Falaise-Chambois-Montormel pocket," the site explains. "This tribute ceremony is the most beautiful

testimony that can be given to a person who gave his life so that we can live free and in peace today. This duty of memory contributes to the preservation of our collective history and to raising awareness among future generations."

Lt. Chaufty's descendants, Nicole Chaufty Saunders and her family from Utah, attended the ceremony, as did Bastien.

Members of the Paul Chaufty Association, including Bastien's daughter, Mireille LeRoyer, association secretary-treasurer; and her husband, association vice-president Herve LeRoyer; along with the organization's president Damien Thierry and his wife Claudine who is a member, visited Chaufty's hometown to pay tribute to him and pay respects at his grave.

Chaufty's story is an integral part of LeRoyer's family history and "for the entire group, it was important to be able to pay tribute to this aviator who gave his life fighting the enemy of the time and to perpetuate the duty of remembrance," the group said in an email prior to the visit, noting the visit would strengthen ties with the Chaufty family.

"What is important is to remember is the sacrifice of these men," LeRoyer said. "Our grandparents were young soldiers during the First World War and then experienced World War II again. For my grandfather, who saw his comrades fall in combat during the First World War, I think it was necessary for him to take care of the soldiers killed on French soil so that they would have a decent burial, especially for soldiers fighting outside their country. This is one of the reasons why he wanted Paul to be buried with his parachute, the parachute being the symbol of his dedication and sacrifice in a foreign land."

The first stop in the village for the French visitors was Lt. Chaufty's final resting place in the family plot in Fairview Cemetery where they were met by members of his family, great nephew Greg and Kim Gilbert of Oswego, great niece Patti Pinkham of Carthage, great niece Shelley Morrison and Marilyn Francois of Chicago. Also in attendance were, representatives of the Veterans of Foreign Wars Post 7227 and Auxiliary, village and town of Wilna historian Lynn Thornton and retired Carthage Central High School French teacher Barbara Huff, who acted as interpreter of the gathering.

The French visitors presented the commemorative books and brochures from last year's tribute ceremony to those present along with plagues to

community of Veterans all throughout our Republic from coast to coast. With one hundred percent certainty my optimism views the "Vallone Veterans Initiative" from a visionary perspective that will flourish far into the future.

Although this is chartering into territory within the vicinity of New York City, I picture this initiative growing well into the future and beyond the confines of the Five Boroughs. I envision the expansion of our claims services beyond New York City, Albany and Buffalo, into other municipalities like my father's (also a Veteran) birthplace of Syracuse and Binghampton, down to the counties of Nassau and Suffolk, and every other locality within the confines of the Department of New York VFW.

Not just for New York City, but ultimately for the Department and for all of our Veterans residing within the beauty of our Great State. This initiative will grow within our Department and organization beyond our borders. I say this with utmost certainty. Not just because I want to but because I believe in this initiative down to my core. Not for our organization but for those we support: Our Fellow Warriors.

As I write this article while conducting outreach in the office of New York City District 19 Councilwoman Vickie Paladino in Whitestone, Queens, I'm reminded of Paul Vallone and his legacy. Councilwoman Paladino's tenure as councilwoman, Paul represented the 19<sup>th</sup> District, his home for many decades. Paul was a friend and someone I enjoyed talking to about the issues within our community and how to resolve them. We all have a little bit of Paul within us. It may not show or we may be too humble to say so, but we will always

have the fire within us to continue working and fighting for our fellow Veterans. Whether at the top tier leadership positions or even at the post level, or working on legislative policy measures or claims, the fire to assist our fellow Comrades will always be within our hearts to continue doing what we do best: "Honoring the Dead by Helping the Living." No matter how big or how small.

family and the VFW with a piece of Chaufty's plane and a medal representing the road that Degaulle and the American soldiers traveled to liberate towns in France.

Annually, people in this French region reenact the route in honor of their thankfulness to those who freed them. The trip takes 10-15 days.

One of the plaques now hangs over the bar at the VFW post.

According to Saunders, the Chaufty homestead was built by her great-great grandfather in 1870. "Their home was the only home Paul ever lived in before he went to war," she said. "It was our Chaufty family homestead from when it was built in 1870 until 1958 or so when it was sold." The current owners, Tom and Kacee Delles, said they retained the woodwork in the house's interior.

Following the visit, LeRoyer emailed, "Paul is part of our lives. Honoring him expresses our gratitude to him, our liberators and our ancestors. Our gratitude is expressed with our heart and in all sincerity. I am proud to have been able to carry out this tribute accompanied by friends, American families, who trusted me. Having gone to Paul's grave on July 18 ends a page in the book of life and the last chapter of my mother's life. Paul died on July 13, 1944, my mother on July 20, 2024. A nice nod to this beautiful adventure that brought us together physically but also in the heart. Remembering, friendship, sincerity, respect, the duty to remember have no borders."

Shelley Morrison said she was grateful to be part of the gathering. Her uncle, Layton Morrison, married Gloria Chaufty, daughter of Harold and Mabel Chaufty. Harold was one of Paul's brothers.

"My aunt Gloria was our favorite aunt," she said. "Paul was her favorite uncle. She was 17 when he was killed. She never forgot him and would tear up whenever she spoke of him." Gilbert said that growing up he had heard stories about his great uncle Paul but now he has the complete story about what happened in France.


# **Featuring: MEMSTATS**

One of the most useful tools for Commanders and Quartermasters on all levels is the Memstats page on the Department's website. The Memstats page is updated from National Monday through Friday each morning.

Commanders and Quartermasters can check this page daily to track the progress of their post or district in membership, inspection status, community service, trustee reports and OTI attendance.


You do not have to sign in to the Members Only page to reach Memstats. It can be found under the **Programs** listing that is located along the top of the Department's Homepage. Memstats is best viewed in Chrome, Firefox, Microsoft Edge or Safari.

Clicking on the word **Programs** will bring you to a drop-down menu of the various programs.



Once you have clicked on the word Memstats, the Memstats homepage will load with the current year's information. The left-hand side of the screen relates to membership information, and the right-hand side of the screen pertains to District/Post requirements. Memstats is based on a July 1<sup>st</sup> through June 30<sup>th</sup> year and not the calendar year.

You can search by either scrolling down through the Districts, which are in numerical order, until you find your Post or you can search for a specific District or Post and/ or year by using the search function in the upper left-hand corner of the page. By clicking on District box, you can either select District or Posttype in the number and click submit for that specific information. When you click on the 2026 box, a dropdown menu will list the years 2019 through 2026 so you can see a Post's or District's information for previous years.





The District/Post membership information is downloaded directly from VFW National's membership database. These membership numbers are used by National to determine when the Membership goal for the year is achieved and to assign the delegate numbers for each Post based on their membership number as of March 31st each year.


The right side of Memstats is color coded blocks for each report and training that is required for the year. The Department needs to receive a yearly inspection, quarterly trustee reports, and an annual 990 for each Post and District. Community Service reports should be submitted as they take place through the Program Reporting page which is found on the Members Only portion of the Department's website.

If a report or training doesn't apply the block will the

black. The report/training blocks will be red until the Department receives the item and verifies it. Once it is verified the block will turn green.

Posts have sponsored their own local chapters, and these chapters form the basis for the group. Earlier this year National published a draft of proposed Bylaws for the VFW Riders that were voted on at the National Convention. These bylaws were not adopted by National, but they continue to work toward some of these policies. Each department, district and post level VFW Riders Group will register as a 501 (c) charitable organization, and they will each have to get their own Tax ID number and elect their own officers and control their own finances independent from the post or district that they are affiliated with. The proposed bylaws also define the requirements and qualifications to become a member including a requirement to own and operate a motorcycle 500cc or larger. They will also propose that \$20 dues be paid to National each year for each member and make attendance and participation with the group mandatory to maintain your membership. The proposed bylaws also require that the Department level groups hold at least two mandatory meetings per year and that meetings can be attended electronically. Thes bylaws are very descriptive and detailed and they go on for 50 pages. These are just some of the highlights that I noted. I would suggest that

department and district officers who have riders groups in their districts become familiar with these bylaws so they can properly operate riders groups within their organizations.

Beyond all this talk about rules and requirements I believe that the VFW Riders can be a valuable part of the VFW as a whole. Many times, at a post or district meeting a post commander from a struggling post will talk about the fact that he has trouble attracting and retaining new members because the perspective members don't see anything that interests them being offered by a post. The riders group is one way to offer members an opportunity to participate in a group within the VFW that lets them engage in an activity that they enjoy with other post members that share their love for riding motorcycles and supporting veteran's causes. In the end attracting new members and keeping existing members engaged is what we all know that we need to do to keep the VFW as a strong and viable organization.


