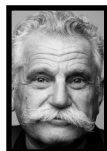

Department of New York. With the start of the new year, it is the perfect time to take advantage of the VFW Foundation's Post Assistance Grant to make some improvements at your Post. This grant is offered exclusively to VFW Posts to offset expenses incurred for building repairs and equipment that enhance or restore the Post's ability to serve veterans and their families. Applicants for this grant are limited to receiving one Post Assistance Grant every three years with the 2023-2024 cycle being the inaugural grant year. The maximum grant award is \$2500.00, and the minimum request amount is \$500.00. Post Assistance Grants are now open and applications can be completed on the VFW Programs Dashboard.

As we have reached the deadline for entries at the Post level for our Voice of Democracy and Patriot's Pen Programs, please ensure that your Post completes their entries on the All-American Programs Dashboard. Post entries can be made by the Adjutant, Quartermaster, Commander, Sr. Vice, or Jr. Vice Commanders. These entries are mandatory for a Post to meet the requirements to qualify as an "All-American" Post. The deadline for Posts to make their Dashboard entries for the Voice of

Comrades,

I'm pleased to report that the pace of the Post inspections coming into the department is picking up and I thank you. Holding onto them to send in as a group ends up hurting the post and is not a good practice. I've been asked "What is the latest date we can turn the inspections in to the department"? The answer is simple, A.S.A.P. The idea is to get individual inspections in as soon as they are completed, allowing posts time to make the necessary corrections. **District Commanders**, let's try to have all posts inspections in NLT at the end of February. If there are issues or anything that I can help you with, don't wait, call me (518 899 4976) so that we can work it out together.

The most common error I'm finding is Quartermaster reconciliation values on the Quarterly Trustee reports. These errors are very noticeable, ranging from 2 cents (which was approved with a comment that the error needs to be found) to as much as \$10000.00. More than one Trustee report has come in with no reconciliation information at all. This makes me wonder if some, fortunately not many, Post Trustees are "Pencil Whipping" these reports. If Post Trustees don't do a thorough job and down the road money goes missing, the post may very well not get the money back. As Trustees we are basically certifying that the report is correct. Inspectors should take a quick look at the Trustee reports before accepting them from the post QM.

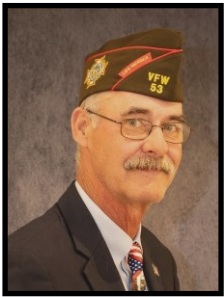

Nominations must show how the nominee displayed efforts that fostered true patriotism by showing and demonstrating a feeling of passion, devotion, and loyalty to America and extended the institutions, traditions, customs, and establishments of American Freedom above and beyond what others would normally do.

To recognize VFW members or citizens for contributions to a better understanding of our American way of life, history, and institutions. Nominations must show how the nominee displayed efforts that perpetuated the memory and history of our dead and/or displayed the importance of American history and why that history is important in our institutions above and beyond what others would do.

VFW Distinguished Citizenship Award

To recognize VFW members or citizens for service rendered through outstanding charitable endeavors to the country or local efforts. Nominations must show how the nominee displayed a high level of benevolent actions and philanthropic allegiance supporting veterans, civil, political and social rights that exemplifies the duties and privileges of being an American citizen above and beyond what others would do.

VFW Distinguished Education Award

To recognize VFW members or citizens for outstanding contribution to the education of the intrinsic values of American freedom and citizenship. Nominations must show how the nominee exemplified through formal, informal or non-formal educational work that teaches the best attributes of patriotism and intrinsic values of knowledge through everyday life above and beyond what others would do.

If you know of a deserving candidate, nominations are due by March 6, 2026, via the Programs Dashboard tool. If you cannot access the Programs Dashboard, work with your District Commander and/or the State Adjutant. For amplifying information or questions, you can

Comrades,

As we wrap up one year and head into another, I would like to review 2025. We began the year with our expansion in New York City. It has come a long way. In January, we had two full-time VSOs working in the Manhattan Regional Office. Both squeezed into a 10ft-by-10ft office. We brought in two more VSOs in April and moved into a large office that easily accommodates all our VSOs. In May, the VSOs along with representatives from the NYC Department of Veterans Services and the VA participated in an outreach event at Citi Field, home of the New York Mets. The event was a great success with close to 300 veterans attending. Also in May, the New York City office was inspected by the VFW's National Veteran Service and received high marks on their report card.

At the national level, the Post/District Service Officer went away. The new position of Post (District) Benefits Advisor was formally adopted at the National Convention in August. The biggest takeaway, the PBA will not handle any Federal (VA) claim related stuff but will be the subject matter expert on local (to include State) benefits available to veterans and families. The updated guide for the Post Benefits Advisor is available on the VFW's website. Nationally, over \$16 billion in veteran's compensation and pension was recovered. In New York State, \$187 million was recouped for veterans and eligible family members represented by the VFW.

As the year ends, we added two more VSOs in NYC and a new VSO in Albany. Another is in the works for NYC to begin the new year. This will give us 12 full time VSOs, a long way from four full time VSOs when I started working for the VFW in 2018. In 2025 the VFW reached an agreement with the National Association of County VSOs for the cross accreditation of their VSOs. This gives us more representation at the local level, expanding our VSO accessibility.

Looking towards 2026, we expect to continue to expand our clientele of veterans and family

members, assisting them with their VA benefits. The two-year renovation project at the Buffalo VA Regional Office has finally finished. We will be back full-time in our new office with three full-time VSOs daily. For those that are familiar with the old office, the new one is still on the sixth floor, but the VA's Public Contact office is now on the first floor. We are looking forward to 2026 and the continued expansion of the services we provide.

email VFW Director of Programs Lynn Rolf III at L.Rolf@vfw.org.

Just as a reminder the Online Membership System (OMS) will be shutting down at 4:00 PM CST on December 31, 2025. Any transactions that are submitted through OMS on Dec. 31, up to the closing time, will be posted to Memstats and Post Query later that evening and available for viewing the morning of Jan. 6, 2026. Mail received at National Headquarters prior to Dec. 30, 2025, will be processed and counted in the December total. The mail received after that date, regardless of the postmark date, will not be counted in the December total. We suggest you have your Posts mail in their membership as early as possible or take advantage of the Online Membership System tools.

The OMS system will be back online for the submittal of transactions by 4:00 p.m. CST, Jan. 1, 2026; however, membership transactions that are processed will not be posted to Memstats until all pertinent data is secured and verified. This should occur on (or before) Jan. 6, 2026.

National is on track in meeting National Commander Carol Whitmore's goal of 101%. As of this writing, the Department is a 91.32% and we are ahead of last year at this point in time. Keep looking to renew those unpaid members in your Post. It is a difficult time of the year weatherwise and the holidays coming very soon but don't get behind the eight ball on recruiting. If we let up, we get farther behind and it gets very difficult to play catch-up. Some Districts are still holding Officer Training Seminars. If you are looking to make All-State there is still time to meet the end of the year deadline to complete your training requirement.

In closing, I would like to wish you and yours a Very Merry Christmas and Happy New Year!

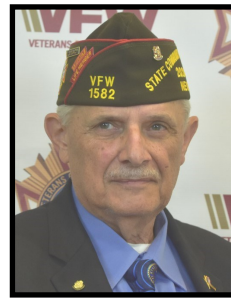

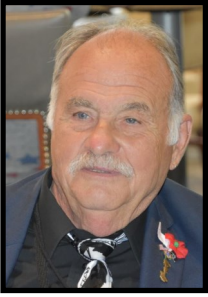

Sgt. Carl J. Vecchio: A Soldier's Journey from Normandy to Captivity and Home Again

Sgt. Carl J. Vecchio's service record reflects the story of an American soldier whose courage, endurance, and devotion to duty carried him across continents and through some of the most grueling chapters of World War II. His military career—preserved in official documents, wartime correspondence, and a hometown newspaper clipping—reveals a man whose strength under fire and perseverance in captivity left a lasting legacy.

Entering active service on May 15, 1942, Vecchio trained as a Heavy Machine Gunner (MOS 605) and later as an Orientation Specialist (MOS 274). His early training prepared him not only for the technical demands of operating heavy weapons but also for leadership. As a squad leader, he was responsible for instructing other soldiers in the use of the heavy machine gun—duties that required calm under pressure and unwavering competence.

During his time overseas in England and France, Vecchio served with distinction. The record notes his work training various units on the machine gun and carrying out the crucial tasks of front-line combat leadership.

On June 13, 1944, only days after the Allied invasion of Normandy, Sgt. Vecchio was wounded and captured by German forces in France. He was subsequently transported deeper into German territory and held as a Prisoner of War at Stalag 3C, a camp located near Küstrin.

Despite the hardships of captivity, Vecchio maintained communication with his family through censored POW mail. One surviving letter addressed to him carries a cheerful, loving message from home—an emotional reminder of the strength that families offered their imprisoned sons, brothers, and husbands.

After months of imprisonment, Vecchio's ordeal came to an end when Soviet troops liberated Stalag 3C on January 31, 1945. The news quickly traveled back to the United States, where it became the subject of a touching newspaper article.

The newspaper clipping recounts how his mother, Mrs. Mary Vecchio of Brooklyn, received notice of her son's liberation on her birthday, the greatest gift she could have imagined after fearing for his safety for

 so long.

The family had been aware that his prison camp was near the advancing Red Army, but confirmation of his freedom brought overwhelming relief.

Following liberation, Sgt. Vecchio returned to the United States and resumed duties as an Orientation Specialist at Camp Croft. His responsibilities included conducting educational discussions, delivering orientation lectures to incoming troops, preparing training materials, and assisting with troop morale and readiness. His work helped returning soldiers transition and new soldiers prepare for overseas deployment.

He was honorably separated from service on October 7, 1945, with an additional brief service entry on November 19, 1920 noted in the document (likely clerical or administrative).

Sgt. Carl J. Vecchio's wartime story—marked by bravery, sacrifice, and resilience—embodies the experiences of countless American servicemen who fought across Europe. From the machine-gun nests of France to the bleak confines of a German POW camp, and finally back to his family in Brooklyn, his journey reflects not only the hardships of war but also the enduring strength of the human spirit.

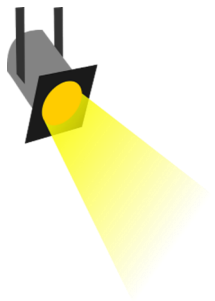
The documents preserved by his family ensure that his service will never be forgotten, allowing future generations to honor a soldier who gave so much in the name of freedom.

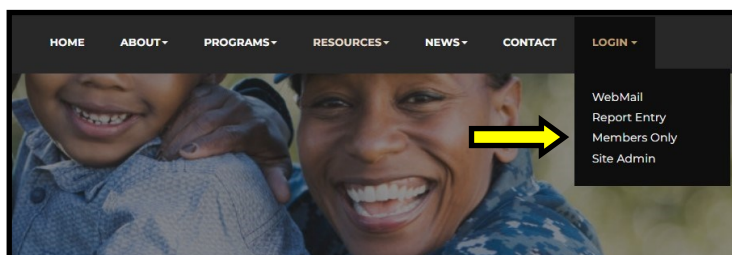

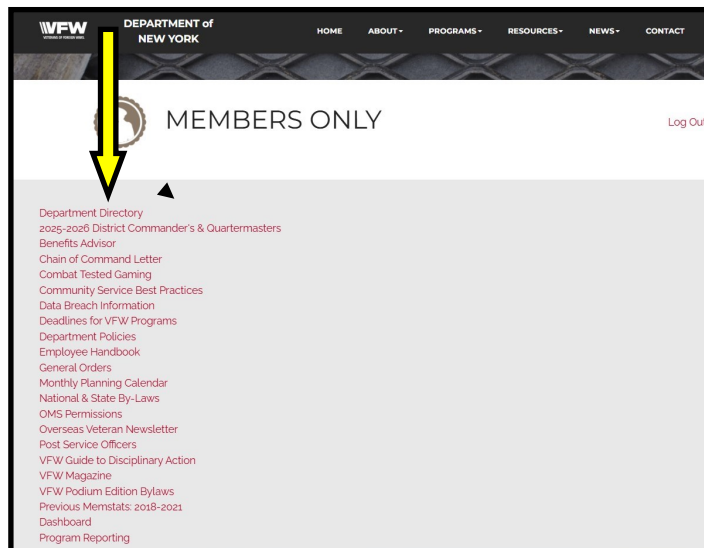

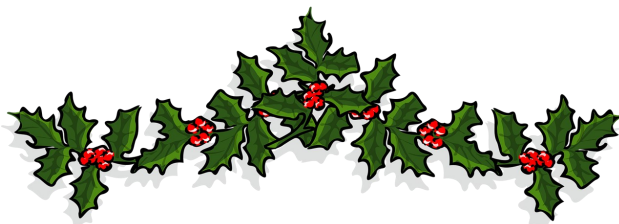
